On Tuesday, February 15, 2011, the City Council voted in Closed Session on Closed Session Item No. 4 in the matter of the *San Diego Municipal Employees' Association, et al. v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2008-00096145-CU-BC-CTL. This case involves a determination by the trial court that a settlement between SDCERS and Judie Italiano was in good faith. The City filed a Writ of Mandamus with the Court of Appeals challenging the trial court's ruling. The Court of Appeals denied the City's Writ. The City Council authorized the filing of a Notice of Appeal.



Report: The Report Out was posted on the 12th Floor of the City Administration Bldg. on Friday, February 18, 2011:

On Friday, February 18, 2011, the City Council voted in Special Closed Session on Closed Session Item No. 1 in the matter of the *City of San Diego v. San Diego City Employees’ Retirement System*, San Diego Superior Court Case No. 37-2010-00091207 CU-WM-CTL. The case involves an action brought by the City of San Diego against the San Diego City Employees’ Retirement System (SDCERS) to

enforce the terms of San Diego Charter section 143 that requires the City and its employees to contribute substantially equally to the cost of the employees' pension benefits. The City Council authorized the City Attorney to file a petition for writ of mandate with the Court of Appeals regarding the trial court's decision to change the venue of this action to Los Angeles County.

The motion passed 6 to 0 with Council President Pro Tem Faulconer and Councilmember Alvarez absent.


