\* ITEM-S500: A Resolution of the Council of the City of San Diego Rescinding Resolution No. Number R-308029 Denying the Appeal and Upholding the Environmental Determination for the Westfield UTC Comprehensive Sign Plan Project (Project No. 298311). (University Community Area. District 1.)

**ITEM DESCRIPTION:**

On March 11, 2013, the City Council heard an appeal of the staff determination for the Westfield UTC Comprehensive Sign Project. The Council denied the appeal and upheld staff's determination. San Diegans for Open Government (SDOG) filed a Petition for Writ of Mandate in the Superior Court, Case No. 37-2013-00044155, alleging that insufficient notice had been given for the public hearing. Upon resolution of the case, the Court found in favor of SDOG and issued a peremptory Writ of Mandate ordering the City Council to set aside Resolution No. R-308029.

**CITY ATTORNEY'S RECOMMENDATION:**

Adopt the following resolution:

Declaring that Resolution Number R-308029, Denying the Appeal and Upholding the Environmental Determination for the Westfield UTC Comprehensive Sign Plan Project (Project No. 298311), is hereby set aside and rescinded.
