Subitem-A (R-2015-140)

Authorizing and directing the Mayor, or his designee, to execute, for and on behalf of the City, the "First Amendment to City of San Diego Linda Vista Branch Non-Profit Lease," between the City and Boys' and Girls' Clubs of Inland North County, a California non-profit public benefit corporation, to amend the current "City of San Diego Linda Vista Branch Non-Profit Lease" for the Linda Vista Branch Boys' & Girls' Club located at 2230 East Jewett Street, San Diego, California.

Subitem-B (R-2015-141)

Declaring that the "First Amendment to City of San Diego Linda Vista Branch Non-Profit Lease," with Boys' and Girls' Clubs of Inland North County, a California non-profit public benefit corporation, to amend the current "City of San Diego Linda Vista Branch Non-Profit Lease" for the Linda Vista Branch Boys' & Girls' Club located at 2230 East Jewett Street, San Diego, California, is categorically exempt from CEQA pursuant to CEQA Guidelines Section 15301 and that an exception to the exemption does not apply under CEQA Guidelines Section 15300.2.
