ITEM-S501: Municipal Code Changes for the City's Permanent Car Share Program. (Citywide.)

**ITEM DESCRIPTION:**

This action is to revise several sections of the San Diego Municipal Code (SDMC) to formalize the City's car share program. This action will provide the City the ability to implement a permanent car share program upon conclusion of the pilot program on October 24, 2015.

**STAFF'S RECOMMENDATION:**

Introduce the following ordinance:

(O-2015-137)

Introduction of an Ordinance amending Chapter 8, Article 6, Division 1 of the San Diego Municipal Code by amending Sections 86.0106, 86.0108, 86.0123, 86.0126, 86.0127; and by adding new Sections 86.0150 and 86.0151, all relating to Car Share and Electric Vehicle Parking.

**STAFF SUPPORTING INFORMATION:**

**FISCAL CONSIDERATIONS:**

This action before the City Council does not have a fiscal impact. Consistent with San Diego City Council Policy 100-05, it is the intent of the City to not incur expenses associated with its involvement of this program. All of the costs associated (e.g. parking stalls reconfigurations, parking metered revenues, etc.) with this program are covered by the operators.

**PREVIOUS COUNCIL AND/OR COMMITTEE ACTION:**

- September 22, 2011(No. R-307015) - Approved of car share pilot program.
- October 25, 2013 (No. O-20433) - Extension of car share pilot program.
- July 29, 2015, this item was heard by the PS&LN Committee and forwarded to the full Council.
