#### PROPOSITION A

#### (THIS PROPOSITION WILL APPEAR ON THE BALLOT IN THE FOLLOWING FORM)

PROPOSITION A. CITY OF SAN DIEGO PARKS AND RECREATION FACILITIES BOND PROPOSAL: Shall the City incur a bonded indebtedness in the principal amount of twenty-five million dollars (\$25,000,000) to permit the acquisition, construction and completion of parks, beaches and other recreational facilities, with sixty-nine percent (69%) of the total bonds authorized to be allocated for neighborhood and community parks, beaches and other recreational facilities, eighteen percent (18%) to be allocated for Balboa Park and thirteen percent (13%) for Mission Bay Park?

This proposition requires a two-thirds vote.

#### TAX RATE STATEMENT

Bonds for parks and recreation facilities in the City of San Diego will be issued in five annual amounts of five million dollars (\$5,000,000) commencing with the fiscal year 1974-75.

The tax rate per one hundred dollars (\$100) of assessed valuation of the real and personal property within the City of San Diego necessary to finance the principal and interest of the proposed twenty-five million dollar (\$25,000,000) bond issue is estimated to be:

a) One and five one-hundredths cents (\$0.0105) for the first fiscal year 1975-76;

b) Five and thirty-seven one-hundredths cents (\$0.0537) for the first fiscal year after the last sale of the bonds which will occur in fiscal year 1979-80;

c) Five and ninety-five one-hundredths cents (\$0.0595) for the highest tax rate which will occur in fiscal year 1982-83.

#### ARGUMENT FOR PROPOSITION A

#### Proposition A is endorsed by San Diego Taxpayers Association.

Proposition A authorizes The City of San Diego to issue up to \$25 million in general obligation bonds over a five year period for acquisition and development of additional parks and recreation facilities for the citizens of San Diego.

The primary source of current funding for city parks and recreation facilities has come from bonds approved by voters in 1966. These funds are nearly exhausted, and a new bond issue is necessary to meet our need for more and improved parks and recreation facilities.

Passage of Proposition A will mean more and better recreational facilities for all San Diegans. 69% of the funds from the bonds proposed will be used to acquire, develop or improve 75 neighborhood and community parks, provide additional recreational facilities at public beaches, and city lakes, and construct three additional municipal swimming pools.

Proposition A will finance improved right-of-way for an intra-park transportation system, a botanical preserve, new picnic facilities, bike and jogging trails and extensive landscaping in Balboa Park, one of the city's most beautiful attractions. Funds may be used to match private funds in the restoration of the Ford Building for the Aero Space Museum.

New public areas in Mission Bay, including portions of Fiesta Island and South Shores will be developed for the enjoyment of all San Diegans. Other proposed improvements to Mission Bay Park include bike trails, tennis courts, additional landscaping and improved beach facilities.

We urge you to vote YES on Proposition A for better parks and recreational facilities, and a better quality of life for all San Diegans.

#### ARGUMENT AGAINST PROPOSITION A

RENTERS and OWNERS alike please vote NO on Proposition A. This is unwise planning and spending.

Facts to think about:

- 1. There are now eight thousand acres in San Diego which are owned by the Park and Recreation Dept.
- 2. Six thousand of these acres are developed and in use as parks. (More than enough)
- 3. Two thousand acres are undeveloped and are more than adequate for the future.
- 4. Balboa Park and other parks are not often used to maximum capacity.
- 5. The Sports Arena and the Stadium could well be turned into parks as they are costly to the taxpayer and serve a small segment of the public infrequently for a large fee.
- 6. What of the millions spent on the old San Diego Stadium and to have it abandoned. It, too, could be turned into a Mini Park.

What do you know of county ordinances, numbers 4015 and 4049. They can cost you hundreds of dollars.

As for providing for the distant future, perhaps those of the future won't appreciate, need or use what the oracles of today plan for them.

Public Servants today are not honoring what those of the past planned for us, ie, liberties being taken in allowing Balboa Park Land to be used for other than Park purposes. Let it be remembered that public servants are elected and expected to serve, not to dictate to, mislead, confuse or deceive the public.

#### PROPOSITION B

#### (THIS PROPOSITION WILL APPEAR ON THE BALLOT IN THE FOLLOWING FORM)

PROPOSITION B. CITY OF SAN DIEGO PARK RESERVE BOND PROPOSITION: Two thirds (%) of the City's Environmental Growth Fund, derived from gas and electric franchise fees, must be used to pay debt service on bonds used to acquire, improve, or maintain park reserve lands for park and recreation purposes.

Shall the City incur a general obligation bonded indebtedness in the principal amount of twenty-two million five hundred thousand dollars (22,500,000) for the acquisition and improvement of Park Reserve lands, pledging in payment of principal and interest thereon two-thirds (2/3) of the Environmental Growth Fund authorized by the Charter of The City of San Diego?

YES

This proposition requires a two-thirds vote.

#### TAX RATE STATEMENT

Bonds to acquire, improve or maintain park reserve lands for park and recreation purposes in the City of San Diego will be issued in five annual amounts of four million five hundred thousand dollars (\$4,500,000) commencing with fiscal year 1974-75.

The City Council has pledged two-thirds  $(\frac{2}{3})$  of the revenue of the Special Environmental Growth Fund for payment of the principal and interest of the proposed twenty-two million five hundred thousand dollar (\$22,500,000) bond issue. The estimated revenue in this fund

should be sufficient to pay all debt service of the bond issue and therefore no tax would be levied for this purpose.

If the City Council had not pledged the above revenue to the payment of the debt service of this bond issue, the estimated tax rate per one hundred dollars (\$100) of assessed valuation of the real and personal property within the City of San Diego necessary to finance the principal and interest of the proposed bond issue would be:

- a) One cent (\$0.0100) for the first fiscal year 1975-76;
- b) Three and seventy-six one-hundredths cents (\$0.0376) for the first fiscal year after the last sale of the bonds which will occur in 1979-80;
- c) Three and seventy-six one-hundredths cents (\$0.0376) for the highest tax rate which would have occurred in fiscal year 1979-80.

#### **ARGUMENT FOR PROPOSITION B**

#### Proposition B is endorsed by San Diego Taxpayers Association.

The citizens of San Diego want to preserve the special character and natural beauty which make this area an ideal place to live. An important element in achieving this goal requires the preservation of land for Park Reserve and general open space. This land must be purchased now while it is still available.

In June 1972 the voters approved a City Charter amendment establishing an Environmental Growth Fund from gas and electric franchise fees. Two-thirds ( $\frac{2}{3}$ ) of this fund is to be used to pay the interest and principal on bonds for the acquisition of Park Reserve lands and their maintenance.

### THEREFORE THE CITY'S TAX RATE WILL NOT BE AFFECTED BY PASSAGE OF THIS BOND PROPOSAL.

Proposition B will authorize The City of San Diego to issue up to \$22.5 million in such general obligation bonds for acquisition of these essential Park Reserve lands and will enable the City to acquire and maintain a sizable portion of 11,190 acres designated by the City Council and Planning Commission as Natural Parks.

Passage of this proposition will earmark \$19.4 million for planned acquisition of 16 community land parcels (totalling 4,580 acres) over a 5-year period, from funds generated by Park Reserve bonds, Special Assessment Districts, and in those cases where appropriate, Federal Revenue Sharing. This proposition will allocate \$3.1 million for land acquisitions within four of the City's major flood plains — San Dieguito Valley, Los Penasquitos Canyon, Otay River Valley, and Tia Juana River Valley.

By voting YES on Proposition B to establish Park Reserve lands, you are adding your voice to those who want to see San Diego remain a beautiful, enjoyable place **AT NO INCREASE IN YOUR PROPERTY TAX.** 

We urge your YES vote.

#### ARGUMENT AGAINST PROPOSITION B

- Re-assessment and increased tax rates are the ever increasing methods which our public servants use to raise money for their grandiose dreams and desires, the public notwithstanding.

Because of those on fixed incomes and others having a hard time because of the high cost of food, housing, medical, taxes and other necessities of life, we must hold the line on unwise spending. We urge a strong NO Vote on Proposition B on Tuesday, September 18, 1973. Thank You.
