PROPOSITION A

<p>A PROPOSITION A. CITY OF SAN DIEGO CHARTER AMENDMENTS. AMEND SECTIONS 70 AND 130 OF THE CHARTER OF THE CITY OF SAN DIEGO.</p> <p>Shall the Charter of The City of San Diego be amended to permit the City Council to enter into an agreement with any recognized employee organization which provides for a schedule of compensation for two consecutive fiscal years, provided that the first year of any such agreement shall be an even numbered calendar year and further, provided that the Council shall incorporate the agreed upon schedule of compensation in the appropriate annual salary ordinance?</p>	YES

This proposition amends the Charter of The City of San Diego by amending Sections 70 and 130. The portions to be deleted are printed in STRIKEOUT TYPE and the portions to be added are underlined.

This proposition requires a majority vote.

Section 70. POWER TO FIX SALARIES

The Council shall have the power to fix salaries of the City Manager, the City Clerk, the City Treasurer, the City Auditor and Comptroller, and all other officers under its jurisdiction. All members of Commissions shall serve without compensation except where otherwise provided by State law or this Charter. Except as otherwise provided by law, the City Manager and other departmental heads outside of the departments under control of the City Manager shall have power to recommend salaries and wages subject to the personnel classification determined by the Civil Service Commission, of all other officers and employees within the total amount contained in the Annual Appropriation Ordinance for personal service in each of the several departments of the City Government. All increases and decreases of salary or wages of officers and employees shall be determined at the time of the preparation and adoption of the budget, and no such increase or decrease shall be effective prior to the fiscal year for which the budget is adopted, provided, however, that The Council shall by ordinance, prior to the beginning of each fiscal year, establish a schedule of compensation for officers and employees in the Classified Service, which shall establish a minimum and maximum for any grade and provide uniform compensation for like service. The Council may, however, enter into an agreement with any recognized employee organization which provides for a schedule of compensation for two consecutive fiscal years, provided that the first year of any such agreement shall be an even numbered calendar year and further, provided that the Council shall incorporate the agreed upon schedule of compensation in the appropriate annual salary ordinance.

+ If during any fiscal year, the Council should find and determine that because of a significant change in living costs, the salaries and wages fixed for such fiscal year are not comparable to the level of other salaries and wages of other public or private employments for comparable services and, as a result, the best interests of the City are not being protected or are in jeopardy, said Legislative Body, upon recommendation of the Manager or other department head, and if funds are available, may revise such salary and wage schedules to the extent necessary to protect the City's interests.

Section 130. ~~COMPENSATION ESTABLISHED~~ SALARY RECOMMENDATIONS.

~~The Council shall by ordinance, prior to the beginning of each fiscal year, establish a schedule of compensation for officers and employees in the Classified Service, which shall establish a minimum and maximum for any grade and provide uniform compensation for like service.~~

It shall be the duty of the Civil Service Commission to prepare and furnish to the Council, ~~prior to the adoption of said ordinance,~~ annually a report identifying classifications of employees in the Classified Service which merit special salary consideration because of recruitment or retention problems, changes in duties or responsibilities, or other special factors the Commission deems appropriate. An increase in compensation, within the limits provided for any grade, may be granted at any time by the City Manager or other appointing authority upon the basis of efficiency and seniority record, after having first received the approval of the Civil Service Commission therefor.

ARGUMENT IN FAVOR OF PROPOSITION A

Proposition A would allow the City to enter into two-year wage and salary agreements with recognized employee organizations. Proposition A does not require two-year contracts, but merely allows them if both parties agree. The overall costs of negotiations in time and money should be reduced when a two-year contract is signed.

There would be more flexibility in a system which permits two-year contracts. Under the current system, the City is restricted to one-year agreements. This allows little time for a breather between settlement and next year's negotiations. There is a need for time to allow the emotional atmosphere of salary discussions to cool down. Now, the City barely reaches a settlement with employee groups before it must start working on the next year's negotiations. Private industry has long realized that there is less labor unrest with multi-year contracts.

There are many issues that the two parties would like to discuss informally. Now it is difficult to debate new issues without getting caught up in the emotional atmosphere of the annual negotiations. When there are indications that there is understanding and partial agreement, both sides may then benefit by taking the issue to the bargaining table.

The employee organizations, for example, would like to see reforms to the entire "meet and confer" process. They see a need to improve methods of settling disputes and breaking "impasse" with the City. The City would like to discuss productivity, incentive pay and Civil Service reform. But in order to find improvement in these areas, both parties must have time to discuss their differences apart from the traditionally heated annual wage and salary negotiations.

Although this proposed Charter amendment is not the total answer, we believe it is a big step in the right direction and urge your approval.

ARGUMENT AGAINST PROPOSITION A

Vote **No** on Proposition A for the taxpayers' sake!

To commit the taxpayers to long-term public employee contracts promising increased salaries and fringe benefits without knowing where the money will be coming from is simply irresponsible. Yet, that's what Proposition A seeks to do.

Currently the City Council must determine the salaries and fringe benefits of public employees on a yearly basis, weighing not only the employee unions' demands but also your ability to pay.

Proposition A, would have the City Council play a guessing game with your money by attempting to forecast the future of the economy and the rate of inflation.

Expensive cost-of-living arrangements go hand-in-hand with Proposition A. It clearly raises the spectre of public employee unions riding the lucrative inflation escalator.

There is no demonstrated record of savings or any other advantage in this risky course of action. All that Proposition A promises is the prospect of increased liability to the taxpayer.

Proposition A basically does only one thing: **It takes the heat off the City Council.**

The council's biggest responsibility is the budget of which the biggest portion goes to employee salaries and benefits.

This is the time when the council must weigh your ability to pay against their unsatiable appetites for additional salaries and fringe benefits.

So why let them bargain away the future? Why guarantee increased salaries on a multi-year basis when we don't even know where the money will come from to pay for critical city services?

Most importantly, it takes away accountability, inasmuch any multi-year contract would be phased in between council elections. If you don't like the decision, you don't even get a chance to vote on it.

Don't let them off the hook. Don't let them gamble with the future of your tax dollars.

ORDINANCE NO. 12685 (NEW SERIES) READS AS FOLLOWS:

ORDINANCE NO. 12685 (NEW SERIES)

AN ORDINANCE AUTHORIZING THE LEASE OR SALE OF CERTAIN PORTIONS OF PUEBLO LOTS 1316, 1317, 1318, 1321, 1351, 1353 AND 1355 OF THE PUEBLO LANDS OF SAN DIEGO, PROVIDED THAT ALL PROCEEDS FROM SUCH LEASES OR SALES BE UTILIZED TO FINANCE POLICE SUBSTATIONS AND OTHER PERMANENT IMPROVEMENTS FOR POLICE PURPOSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City of San Diego be and it is hereby authorized and empowered to lease or sell all or any portion of the remaining unratified portions of Pueblo Lots 1316, 1317, 1318, 1321, 1351, 1353 and 1355 consisting of a total area of approximately 400 acres more or less. The aforementioned Pueblo Lots are located generally in the area of Interstate 805 in the University City area southerly of Sorrento Valley Boulevard, as more particularly shown on that plat on file in the office of the City Clerk as Document No. 766676.

Section 2. All leases or sales of the above described Pueblo Lots shall be made for the general purpose of accommodating scientific research activities, manufacturing research and development activities, corporate headquarters, high technological-like manufacturing activities and related or similar uses.

Section 3. All proceeds from lease or sales of the above described Pueblo Lots shall be placed into a Capital Outlay Fund to be used solely and exclusively for the purpose of financing acquisition and construction of police substations and other permanent improvements for police purposes.

Section 4. This ordinance requires ratification by the voters and being related to elections is of the kind and character authorized for passage on its introduction by Sections 16 and 17 of the Charter.

Section 5. This ordinance shall become effective only after it is affirmatively approved by a majority vote of the qualified electors of the City of San Diego voting at a Special Municipal Election to be held in said City on the 18th day of September 1979, at which a proposition to ratify this ordinance shall be submitted.

ARGUMENT IN FAVOR OF PROPOSITION B

Better police service can be assured by the passage of Proposition B. It requires that the city use the proceeds from the lease or sale of 400 acres of city-owned land to finance neighborhood police substations.

San Diego needs improved police protection. The construction of these neighborhood substations would permit decentralization; stationing police officers closer to you for quicker and more efficient protection.

The lease or sale of this city-owned surplus property will do more than just finance improved neighborhood police services and protection. It also offers the chance to create jobs for San Diegans and reduce your individual tax burden by expanding the tax base.

These currently unusable lands are located along Interstate 805 in the vicinity of Sorrento Valley. The uses permitted by Proposition B are consistent with adopted community plans and include scientific research activity, manufacturing research and development, corporate headquarters and high technology light manufacturing. In other words, it will permit the kind of clean industry that has proven to be advantageous to our environment and economy.

The people of San Diego need improved police services and a stronger economy. Passage of Proposition B provides for both these needs.

Proposition B permits the construction of neighborhood police substations without imposing additional taxes on you the taxpayer.

The time to act is NOW! VOTE YES ON PROPOSITION B.

ARGUMENT AGAINST PROPOSITION B

VOTE NO ON PROPOSITION B!

Selling city land is bad business. It costs us money.

These prime 400 acres located in Sorrento Valley and adjacent to University Towne Centre are too valuable to sell off. They will return many times as much money to us if leased, than they ever will from sales price and property taxes if sold.

Don't let the wording "lease or sale" mislead you.

Less than one year ago, you voted down a similar proposition to sell this same land.

The argument you supported then was that the land should be **leased**—not sold. The Mayor and Council wanted to sell this land then and they want to sell it now.

Save this remaining heritage. Of the original 50,000 acres of Pueblo Land only about 800 acres are left to us.

Fortunately, **we can use the land today** and still retain our options on future uses simply **by leasing instead of selling.**

Had we retained public ownership of the original pueblo lands, leasing to anyone who wanted to use on fair long-term leases, there would be no need to expend hundreds of millions on urban renewal! Certainly there would be no need for taxes to support municipal services today! Mission Bay is a model of what can be accomplished when leases are utilized and sales prohibited.

Leases promote good use of land—sales lead to land speculation.

A city staff report dated 7/12/79 stated that sales currently under consideration represent "a substantial taxpayers' gift in land value," attract "a very few highly paid executives," and provide "benefits that are speculative and not guaranteed."

Reject these short-sighted and politically motivated propositions which will invariably end up costing us manyfold what we will gain today.

C PROPOSITION C. ARGUMENT AGAINST PROPOSITION C

Opposition to diversion of sales tax.

In passing Propositions G & J, 75% of the voters in San Diego voted to establish spending limits in the county and city respectively. Proposition 13 was overwhelmingly passed

by the voters in an effort to tell government to **cut back** their spending, not increase it. Proposition C asks you the voters, whether or not you want to have the Governor and state legislature allocate 2¢ of the state sales and use tax to local governments rather than the current 1¢. I believe that this is **not** the will of the people. This proposal is in direct opposition to the philosophies set forth by Propositions G, J, & 13, which preclude the need for any additional revenues.

The real issue we need to address is not where our revenues will come from, and how much, but is one which deals with the current inequities of our tax system. Proposition C does not address the issue of tax inequities. What is required is a major overhaul of our present tax system based on evaluations of public services from a regional perspective.

As a result of these propositions, local governments are cutting back unnecessary fat, and effectively consolidating departments and programs. Asking for additional revenues will put us right back where we started. I urge you to vote no on Proposition C.

ARGUMENT IN FAVOR OF PROPOSITION D

YES ON D — FOR A BETTER BALBOA PARK

A Yes Vote on Proposition D is a Yes Vote for a better Balboa Park. Its passage would add 38.9 acres of prime-view parklands to Balboa Park, providing a much-needed expansion of recreational and picnic areas to serve our growing population.

In return for the 38.9 acres of premium property, including Inspiration Point, the City would allow the Navy to use 38.9 acres of less desirable property. The land—a former dump—is full of brush, debris and a few cactus. Sixteen acres are now used for city maintenance.

The Navy is willing to give the City Inspiration Point and the surrounding view land because the other acreage off Florida Drive is more suitable for building the new hospital facilities necessary to replace some of the current buildings, some of which are obsolete and unsafe. The improvement of Balboa Hospital is considered crucial by the Navy. It is the world's largest and busiest military medical complex. Its staff treats more than 1.1 million patients each year and provides training for 40 percent of all Navy health care professionals.

The Navy is committed to improving Balboa Hospital with new medical buildings, new

landscaping and an enhancement of the entire site off Florida Drive which now stands relatively unused.

Passage of Proposition D would give the City very desirable and accessible parklands that would benefit all San Diegans.

The exchange would also save taxpayers untold millions of dollars. The Navy is ready to improve its obsolete facilities today. Costly delays in finding other land would create added tax burdens.

A Yes Vote on Proposition D is truly a Yes Vote on a better Balboa Park. Its passage will mean a better park and a better hospital for all of us.

ARGUMENT AGAINST PROPOSITION D

Your NO vote on "D" will make Balboa Park a better park and will encourage the Navy to build a better Navy Hospital on a better site.

"D" is No Deal for the Navy. The proposed hospital site in Balboa's Florida Canyon will cost the taxpayers extra money because of (1) building on the steep canyon slopes, (2) soundproofing against the excessive aircraft noise, (3) using inefficient old buildings, and (4) building new freeway access roads.

"D" is No Deal for Balboa Park. The hospital in the heart of Balboa Park would (1) destroy the open space of Florida Canyon, (2) bring the hospital traffic into the center of the park, and (3) ignore the need of San Diego for more park and open space.

Alternate sites for the hospital are better. There are alternate sites which are away from the aircraft flight path, that have level land and provide ideal freeway access. Sites on City land, downtown sites and sites on Navy land offer these advantages to build an entirely new efficient hospital cheaper than that proposed in Balboa Park.

Park use is best for Balboa Park. The need for the park increases yearly as more people come to live in San Diego. The park is also very important to maintain the strength of our tourism business. We have lost more than 350 acres of Balboa Park to freeways, schools and the hospital. Now is the time to say NO to renewing hospital use of Balboa Park land. We need the whole park to be all park.

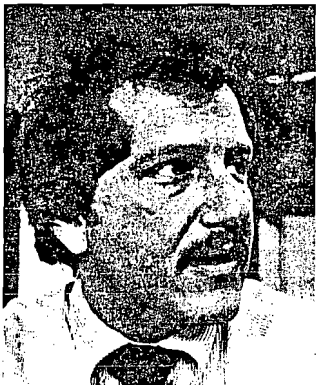
