COUNTY OF SAN DIEGO

PROPOSED AMENDMENT TO THE CHARTER OF THE COUNTY OF SAN DIEGO. Shall the Charter be amended to (1) limit appointive authority of Board of Supervisors; (2) prohibit Board of Supervisors from interfering with subordinates of Chief Administrative Officer, except to seek information; (3) authorize removal of the Chief Administrative Officer by a majority vote of Board of Supervisors; (4) place specified managers in the Unclassified Service; and (5) make other changes related to the County's personnel system?

SAN DIEGO COUNTY WATER AUTHORITY

PAMO RESERVOIR PROJECT REVENUE BONDS

Shall the San Diego County Water Authority issue revenue bonds in the principal amount of up to \$82,000,000 pursuant to the Revenue Bond Law of 1941 to provide funds for the acquisition and construction of the Pamo Reservoir Project for the Authority comprising a 130,000 acre foot water storage reservoir, a pumping plant and power plant, together with necessary lands and easements therefor, and other works, property and structures necessary or convenient for the reservoir project for the Authority and increase rates for water as necessary to satisfy the covenants contained in resolutions approving the issuance of the bonds and necessary to market the bonds."

RATIFICATION OF ORDINANCE NO. 0-16248 (NEW SERIES).

Shall Ordinance No. 0-16248 (New Series) entitled, "AN ORDINANCE AUTHORIZING THE ACCEPTANCE FROM THE SALK INSTITUTE FOR BIOLOGICAL STUDIES (SALK) OF A PORTION OF PUEBLO LOT 1324 CONSISTING OF 2.57 ACRES OF SALK PROPERTY TO BE ADDED TO TORREY PINES CITY PARK AND AUTHORIZING THE ACCEPTANCE IN ADDITION OF \$350,000.00 TO BE USED FOR PARK ACQUISITION AND IMPROVEMENTS, IN EXCHANGE FOR A CONVEYANCE BY THE CITY TO SALK OF 2.3 ACRES OF DEDICATED TORREY PINES CITY PARK LAND NOW USED AND TO BE USED BY SALK FOR RESEARCH PURPOSES," adopted by the Council of The City of San Diego be ratified?

This proposition requires a two-thirds vote.

ORDINANCE NO. 0-16248 (New Series) READS AS FOLLOWS:

AN ORDINANCE AUTHORIZING THE ACCEPTANCE FROM THE SALK INSTITUTE FOR BIOLOGICAL STUDIES (SALK) OF A PORTION OF PUEBLO LOT 1324 CONSISTING OF 2.57 ACRES OF SALK PROPERTY TO BE ADDED TO TORREY PINES CITY PARK AND AUTHORIZING THE ACCEPTANCE IN ADDITION OF \$350,000.00 TO BE USED FOR PARK ACQUISITION AND IMPROVEMENTS, IN EXCHANGE FOR A CONVEYANCE BY THE CITY TO SALK OF 2.3 ACRES OF DEDICATED TORREY PINES CITY PARK LAND NOW USED AND TO BE USED BY SALK FOR RESEARCH PURPOSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City of San Diego is hereby authorized to convey to The Salk Institute for Biological Studies the following described pueblo lands presently dedicated for park purposes as a part of Torrey Pines City Park:

Approximately 2.3 acres of Pueblo Lot 1324 of the Pueblo Lands of The City of San Diego identified as Parcel One on Exhibit A attached hereto.

to be used for the purpose of research in biology, the cause, prevention and cure of disease, and for such other purposes as may be approved by the Council of The City of San Diego.


Section 2. That the authorization for such conveyance shall be subject to the following conditions:

(a) That The Salk Institute for Biological Studies shall convey to The City of San Diego the following described pueblo lands:

Approximately 2.57 acres of Pueblo Lot 1324 identified as Parcel Two on Exhibit A attached hereto.

to be dedicated by said City of San Diego for park purposes as a part of Torrey Pines City Park;

(b) The Salk Institute for Biological Studies shall pay to The City of San Diego the sum of \$350,000.00, which sum shall be used for park acquisition and improvement.



Section 3. This ordinance shall become effective only after it is affirmatively approved by a two-thirds vote of the qualified electors of The City of San Diego voting at the general election to be held in said City on the 6th day of November, 1984, at which time such proposition of ratifying this ordinance is submitted.

ARGUMENT IN FAVOR OF PROPOSITION C

The Salk Institute is working on solutions to some of the most complex medical problems. Your yes vote on Proposition C can help continue that work. This measure already has the unanimous support of the City Council, the Park and Recreation Board and the board's Coastal Committee.

Since the early 1960s, medical researchers at the Institute have been working to solve the most fundamental medical mysteries known to humankind, including studies on the brain and nervous system, cancer, birth defects, stress and diabetes.

To keep this work at the forefront of scientific research, the Institute and its supporters ask your support for Proposition C.

Proposition C authorizes a land exchange between the City and The Salk Institute.

With approval of this measure, Salk will transfer to the City 2.57 acres of Salk-owned land, which will be dedicated as part of Torrey Pines City Park. Additionally, because of a difference in appraised value between the Salk property and the city-owned land, the institute will also pay the City \$350,000 to be used for acquiring and improving parks.

The City will transfer to Salk 2.3 acres of land, property which has been occupied by Salk for many years under a permit from the City. The City can no longer allow use of the property under such a permit. The Salk Institute built expensive temporary research facilities on the site and those buildings are needed until new permanent research buildings can be built.

This land exchange, which will ensure uninterrupted medical research at The Salk Institute, has the unanimous support of the City Council, the Park and Recreation Board and its Coastal Committee. Proposition C makes good sense for San Diegans.

The proposed exchange is in the best land use, health and economic interests of the City of San Diego.

ARGUMENT IN FAVOR OF PROPOSITION D

The issue here is the right of San Diego taxpayers to name their own stadium. The issue is $\underline{\mathsf{NOT}}$ Jack Murphy or his family.

In October 1966, the people of San Diego named their stadium SAN DIEGO STADIUM.

In 1981, a local newspaperman approached the San Diego Stadium Authority requesting the name be changed to Jack Murphy Stadium. The Stadium Authority voted unanimously <u>against</u> the Change.

In spite of this the former Mayor and City Council, on request of the same individual, changed the name to San Diego Jack Murphy Stadium which is usually shortened to Jack Murphy Stadium.

No public hearings were ever held nor was any notice ever given that this move was being contemplated!

Because of enormous outcries from the people of San Diego, the Mayor and the City Council, in July, 1984, have recognized the public's right and the democratic process in placing this measure on the ballot by an overwhelming 8-1 vote.

Busch, Wrigley, et. al., built, owned, and named their stadia. The public names their stadia.

In deciding this issue, San Diego will not "be embarrassed" nor "a laughing stock of the nation", as a few people would wish you to believe, any more than Cape Canaveral was when it restored its name after two years of Cape Kennedy or Seattle and Tacoma with their International Airport were after five months as Henry M. Jackson International Airport. The families of the late President and Senator accepted restoration of the original names with grace, dignity, and understanding, just as one would expect of Jack Murphy's family.

The City budgets over \$3,000,000 to promote San Diego. With the national attention television and radio give our sports events, what better way to publicize San Diego but with our greatest asset - SAN DIEGO STADIUM.

We urge you to vote YES on this measure.
