CITY OF SAN DIEGO CHARTER AMENDMENT AMENDING SEC-TION 11.1 OF THE CHARTER OF THE CITY OF SAN DIEGO AND ADDING SECTION 11.2.

SECTION 11.1. LEGISLATIVE POWER --- NONDELEGABLE.

Imposes upon City Council same prohibition against delegating legislative power or responsibility as State Constitution imposes on the State Legislature regarding raising and spending public monies.

Establishes guidelines for Council consideration in setting employee compensation.

Requires City Council to give priority to police protection in setting compensation of City employees.

Extends the prohibition against unlawful delegation to any scheme or formula which seeks to fix, establish or adjust the compensation of City of San Diego employees at the level of the largest cities in California or the State of California.

SECTION 11.2. LEGISLATIVE POWER — MEMORANDUM OF UNDER-STANDING.

Notwithstanding any provisions of this Charter to the contrary, nothing in this Charter shall be construed to preclude the Council from entering into a multiple year memorandum of understanding with any recognized City employee organization concerning wages, hours and other terms and conditions of employment if, in the prudent exercise of legislative discretion as provided in this Charter, the Council determines it is in the best interests of the City to do so; and further provided that said exercise of legislative discretion is expressed affirmatively by a two-thirds vote of the entire Council.

INITIATIVE MEASURE. AMENDS THE CHARTER OF THE CITY OF SAN DIEGO BY ADDING SECTION 130.1.

The Council shall establish, for fiscal year 1986-1987, a base salary for the classification of Police Officer II, which is not less than the average base salary for comparable police officer positions in the California Highway Patrol and the police departments of the four (4) largest cities by population in the State of California. In determining the average salaries, no California city will be considered if that city is required to use an averaging formula for determining police officer salaries. All other classifications in the police unit shall receive a percentage base salary increase equal to that for Police Officer II as determined in the above manner.

The establishment of salaries for police classifications using the above formula for fiscal year 1986-1987 shall not require an increase in the annual tax levy.

Proposition E

(This proposition will appear on the ballot in the following form.)

CITY OF SAN DIEGO CHARTER AMENDMENT AMENDING SEC-TION 11.1 OF THE CHARTER OF THE CITY OF SAN DIEGO AND ADDING SECTION 11.2.

SECTION 11.1. LEGISLATIVE POWER — NONDELEGABLE.

Imposes upon City Council same prohibition against delegating legislative power or responsibility as State Constitution imposes on the State Legislature regarding raising and spending public monies.

Establishes guidelines for Council consideration in setting employee compensation.

Requires City Council to give priority to police protection in setting compensation of City employees.

Extends the prohibition against unlawful delegation to any scheme or formula which seeks to fix, establish or adjust the compensation of City of San Diego employees at the level of the largest cities in California or the State of California.

SECTION 11.2. LEGISLATIVE POWER — MEMORANDUM OF UNDER-STANDING.

Notwithstanding any provisions of this Charter to the contrary, nothing in this Charter shall be construed to preclude the Council from entering into a multiple year memorandum of understanding with any recognized City employee organization concerning wages, hours and other terms and conditions of employment if, in the prudent exercise of legislative discretion as provided in this Charter, the Council determines it is in the best interests of the City to do so; and further provided that said exercise of legislative discretion is expressed affirmatively by a two-thirds vote of the entire Council.

This proposition amends the Charter of The City of San Diego by amending Section 11.1 and adding Section 11.2. The portions to be deleted are printed in STRIKEOUT TYPE and the portions to be added are <u>underlined</u>.

This proposition requires a majority vote.

SECTION 11.1 LEGISLATIVE POWER - NONDELEGABLE.

The same prohibition against delegation of the legislative power which is imposed on the State Legislature by Article XI, Section 11a of the Constitution of the State of California shall apply to the City Council of The City of San Diego, so that its members shall not delegate legislative power or responsibility which they were elected to exercise in the adoption of any ordinance or resolution which raises or spends public monies, including but not limited to the City's annual budget ordinance or any part thereof, and the annual ordinance setting compensation for City employees, or any ordinance or resolution setting public policy.

The City Council shall annually adopt an ordinance establishing salaries for all City

In setting compensation for City employees, tThe City Council shall adopt an this ordinance no later than May 30 of each year after considering all relevant evidence including but not limited to the needs of the citizens of the City of San Diego for municipal services, and the ability of the citizens to pay for those services, local economic conditions and other relevant factors as the Council deems apropriate provided, however, that, tThe City Council shall give priority in the funding of municipal services to the need of the citizens for police protection in considering adoption of this salary ordinance and the annual budget ordinance.

The prohibition imposed by this section against unlawful delegation of the legislative responsibility to set compensation for City employees shall extend to any scheme or formula which seeks to fix the compensation of City of San Diego employees at the level of compensation paid to employees of any other public agency whose governing board is not elected by and not accountable to the people of the City of San Diego. This prohibition shall also extend to any scheme or formula which seeks to fix, establish, or adjust the compensation of City of San Diego employees at the level of the largest cities in California or the State of California.

SECTION 11.2. LEGISLATIVE POWER -- MEMORANDUM OF UNDERSTANDING.

Notwithstanding any provisions of this Charter to the contrary, nothing in this Charter shall be construed to preclude the Council from entering into a multiple year memorandum of understanding with any recognized City employee organization concerning wages, hours and other terms and conditions of employment if, in the prudent exercise of legislative discretion as provided in this Charter, the Council determines it is in the best interests of the City to do so; and further provided that said exercise of legislative discretion is expressed affirmatively by a two-thirds vote of the entire Council.

ARGUMENT IN FAVOR OF PROPOSITION E

POLICE PROTECTION WILL REMAIN SAN DIEGO'S FIRST PRIORITY.

Proposition E reaffirms the clear direction voters gave to the City Council in 1980.

Police protection comes first when budgeting and setting employee salaries.

During the past six years, the City Council has consistently followed that direction.

The San Diego Police Officers Association and the City have a new two year labor contract which provides a 17% pay increase for the City's Police Officers.

THE SAN DIEGO POLICE OFFICERS ASSOCIATION HAS FORMALLY ENDORSED THIS PROPOSITION.

SAN DIEGO HAS ADDED 269 POLICE OFFICERS SINCE 1980.

Keeping crime under control requires adding police officers.

The City Council has added 269 police officers since 1980 and has plans to continue to add more police officers until we have 2 for every 1,000 San Diegans.

We will have a safer city and safer police officers only if we are able to keep adding officers to our force.

Proposition E guarantees that our progress in officer safety will continue.

PROPOSITION E KEEPS LOCAL CONTROL OVER POLICE PROTECTION.

We should ensure that the City Councils of Los Angeles, Oakland, San Jose and Long Beach not be allowed to decide what San Diego police should be paid.

If that happens, San Diego may not be able to maintain the current level of police protection because it would have to pay existing officers more money.

Your City Council should make local decisions about police. Don't be fooled by the scheme to let people you don't even elect make these important decisions.

PROPOSITION E GIVES OUR POLICE NEW PROTECTION.

For the first time, police and other City employees could receive multi-year contracts, helping achieve better employee relations.

Multi-year contracts lock in salaries in advance, offering employees the protection of knowing what the future holds.

(This proposition will appear on the ballot in the following form.)

INITIATIVE MEASURE. AMENDS THE CHARTER OF THE CITY OF SAN DIEGO BY ADDING SECTION 130.1.

The Council shall establish, for fiscal year 1986-1987, a base salary for the classification of Police Officer II, which is not less than the average base salary for comparable police officer positions in the California Highway Patrol and the police departments of the four (4) largest cities by population in the State of California. In determining the average salaries, no California city will be considered if that city is required to use an averaging formula for determining police officer salaries. All other classifications in the police unit shall receive a percentage base salary increase equal to that for Police Officer II as determined in the above manner.

In determining the average salaries, no California city will be considered if that city is required to use an averaging formula for determining police officer salaries. All other classifications in the police unit shall receive a percentage base salary increase equal to that for Police Officer II as determined in the above manner.

The establishment of salaries for police classifications using the above formula for fiscal year 1986-1987 shall not require an increase in the annual tax levy.

ARGUMENT IN FAVOR OF PROPOSITION F

If we want the best, we have to pay for it. If we want well trained, experienced police, we have to pay a salary that will attract and keep them. That is why we must vote "Yes" on the Police Pay Initiative.

San Diego Police are underpaid. San Diego is California's second largest city, yet 46 other California communities pay their police officers more. Many San Diego officers cannot afford homes in San Diego. We don't pay them enough. Yes, we have superb officers on our Department. But to keep them, and to increase their numbers, we must increase their paychecks.

Doing the right and honorable thing - voting yes on this proposition - will not cause a taxincrease; neither, will it decrease any essential services. The only programs Council has to cut are their own pet projects. Don't believe the horror stories. This initiative will cost only slightly more than 1% of the City's budget.

San Diego is the most dangerous city in the nation for police officers. San Diego officers are on duty around the clock, on weekends and holidays keeping us safe. They risk their lives to protect us.

ARGUMENT AGAINST PROPOSITION F

THE POLICE OFFICERS ASSOCIATION HAS PUBLICLY WITHDRAWN ITS SUPPORT FOR THIS PROPOSITION.

The Police Officers Association and the City recently entered into a two year labor contract which provides a 17% pay increase over the next two years. This contract has been ratified by the City's Police Officers and the City Council.

APPROVAL OF PROPOSITION F WOULD DESTROY THIS CONTRACT AND WOULD DISRUPT THE CITY'S LABOR PEACE.

PROPOSITION F WOULD NOT ADD A SINGLE OFFICER AND COULD ACTUALLY REDUCE THE NUMBER OF POLICE.

Proposition F would grant existing San Diego police officers a 17% pay raise the first year alone.

But since Proposition F allows no new taxes, the \$10 million it would cost would have to be cut from existing City programs.

That means we would have to eliminate police positions to pay officers the 17% salary increase in one year.

Or the City Council would be forced to cut from other programs — parks, libraries, street sweeping and road repairs.

PROPOSITION F IS BAD LAW. IT MEANS CITY COUNCILS IN LOS ANGELES, OAKLAND, LONG BEACH AND SAN JOSE WOULD SET THE PAY FOR SAN DIEGO POLICE.

PROPOSITION F IS UNFAIR TO OTHER CITY EMPLOYEES.

Other employee unions are anxiously watching.

If all City employees received the same 17% raise, it would cost taxpayers <u>\$30 million</u> <u>a year more than we are paying today.</u>

SAN DIEGO DECISIONS SHOULD BE MADE HERE BY YOU.
