# **City Council Targets Abandoned Properties**

Sherri successfully fought to pass tough new measures to more effectively deal with abandoned properties that negatively impact neighborhoods throughout the city.

The Abandoned Properties Ordinance, which the City Council passed unanimously on Sept. 18, expands the definition of what constitutes an abandoned property and imposes more stringent maintenance requirements while making it easier for police and code inspectors to respond to nuisance properties.

The ordinance allows the city to be more aggressive in addressing vacant properties, especially those that have become unsightly because of litter and debris or that have become centers for gang or other illegal activity. It also addresses vacant foreclosed properties, which blight neighborhoods and bring down property values.

Sherri pushed aggressively for the ordinance when she served as chair of the Land Use and Housing Committee because she sees abandoned properties as everyone's problem.

The ordinance also requires vacant property owners to file a statement of intent on their plans for the property, helping return these vacant properties to more productive uses faster.



The Abandoned Properties Ordinance closes loopholes and beefs up enforcement tools so the city can be more proactive in addressing these eyesores.

"This ordinance is about nipping in the bud the problems abandoned properties inflict on our neighborhoods and fasttracking their rehabilitation," Sherri explained.

# **City Council Acts to Protect Local Military Economy**

Under Sherri's leadership, the City Council approved a resolution affirming the City of San Diego's commitment to protect its local military operations from looming federal defense spending cuts.

The resolution, which Sherri sponsored, calls on elected officials, business leaders and the community to fight the threat of these budget reductions to our local military economy.

According to the San Diego Military Advisory Council (SDMAC), if these federal budget cuts, known as sequestration, are enacted, it could result in the loss of 31,000 San Diego jobs.

The resolution is designed to reinforce the work of "Operation San Diego," which is a collaboration between four San Diego business groups, including the San Diego Regional Economic Development Corporation, the San Diego Regional Chamber of Commerce, CONNECT and SDMAC to prevent the potential cuts. "This is just one step of many that we need to take to protect one of our most important economic sectors – the military," Sherri said. "No one should doubt our resolve to protect these local jobs or that we are united in this cause."

Other municipalities are following San Diego's lead and are working to enact similar resolutions. For instance, the Los Angeles County Economic Development Corporation is asking its member cities to do the same.

# A Solution to Oversized Vehicles on Carmel Vista Road



Sherri worked with police and traffic engineers to prevent RVs from parking on Carmel Vista Road.

In recent months, Sherri's office received numerous emails, phone calls, letters and petitions from residents living near Carmel Vista Road regarding the number of oversized vehicles parked on that street.

Adding to neighbor's concerns, this summer one of the RVs parked on Carmel Vista Road caught fire as a result of an electrical malfunction.

Sherri requested that the Police both sides of Carmel Vista Department's Traffic and Park-

ing Enforcement officers attend a community meeting to get community input on solutions to the problem.

Engineers and the Police Department to come up with a solution that would prevent RVs from parking on Carmel Vista Road.

On September 27, new parking "T"s were installed along Road, which make it illegal for

any vehicle longer than 24-feet to be parked on Carmel Vista Road at any time.

In addition, at Sherri's request, Sherri also worked with Traffic the city's Storm Water Department performed a thorough sweeping of Carmel Vista Road to ensure the street is clean now that the RVs are gone.

# Genesee Avenue Resurfacing

In September, the city repaved Genesee Avenue in University City between Governor Drive and Executive Drive.

Sherri had advocated for the resurfacing to be a part of the more than 35 miles of resurfacing in District One that has been completed since she took office.

There's now smooth pavement on Genesee all the way from SR -52 to North Torrey Pines Road.

# Working Toward a Solution for La Jolla Cove's Odor Issues

Sherri's office has been working tirelessly with the community to find a solution to the odor problem at La Jolla Cove.

The smell is the result of bird waste building up on the bluff.

One promising suggestion is to use an environmentally friendly, biodegradable product, which has been used in other parts of the country, to clean the area.

Since the bluff is under the jurisdiction of the Coastal Commission, any solution would need to get clearance from this agency as well as the Regional Water Quality Board.

Sherri has scheduled a meeting with all the stakeholders — the community, the Coastal Commission, the Regional Water Quality Board, makers of the cleaning products, and the City's Park and Recreation Department — to get their support for moving forward.

"Working together, I know we can come up with an environmentally sound and sensible solution that passes legal muster," Sherri said. "We are making real progress on this issue."

# **Update: Torrey Pines Corridor Project**

The Torrey Pines Corridor Project continues to makes steady progress.

The full project, which is estimated to cost \$26 million, would beautify and improve this important stretch of road by building retaining walls, improving sidewalks and adding fencing, landscaping and bike lanes. While finding funds for such a large-scale project is difficult in these tough economic times, Sherri continues to look for additional sources of funding to complete this important project.

The City is moving forward with much-needed sidewalk improvements on the north side of the road to create a safe sidewalk all the way from the Village to La Jolla Shores and the construction of a new sidewalk from Calle Juela to Roseland Drive on the south side of the road. The cost for these two improvements is \$1 million.

Design and survey work is already under way and construction on the sidewalk improvements is scheduled for 2013. "Sidewalk improvements on the north side and a new sidewalk from Calle Juela to Roseland Drive on the south side are funded and moving forward now."

After her own battle with ovarian cancer, Dr. Laura Shawver established The Clearity Foundation to explore the genetic signature of ovarian cancers and improve treatment options for patients. The upside: The Clearity Foundation provides doctors access to molecular profiling for their patients as well as access to novel therapeutics in a clinical trial setting. It also offers financial support for the profiling work if a patient is unable to pay for it or it is not covered by her insurance.
