City Clerk Opens One-Stop Shop for Passport Services

On July 1, Sherri joined City Clerk Elizabeth Maland in cutting the ribbon on the City's new Passport Acceptance Facility.

Sherri was the first official passport applicant at the facility's grand opening, which was attended by representatives of the State Department and the National Passport Immigration Center.

Conveniently located in the first floor lobby of the City Administration Building, the Passport Acceptance Facility serves as a one-stop shop for applicants, offering both passport application and photo services for a small fee. In the month since its opening, the facility has already generated \$2,950 in extra revenue for the city.

U.S. citizens interested in applying for their passport can call (619) 533-4050 to set up an appointment Monday through Friday, between the hours of 9:00 a.m. and 4:00 p.m.

Walk-in service is currently not available.

The city recently welcomed a new director to the Planning and Neighborhood Restoration Department.

Appointed to the position in June, California's leading planning expert, Bill Fulton, officially began work for the city on July 8.

With decades of experience in city planning, and national recognition as a leader in smart growth and transitoriented development, Sherri is confident that Fulton will bring innovation, enthusiasm and positive changes to the city's Planning Department.

Since beginning his new position, Bill has already met with Sherri to discuss bringing forward a comprehensive economic development strategy for San Diego to her Rules and Economic Development Committee in the fall.

Bill also is looking into how to begin updating the city's out-

dated Community Planssomething Sherri has advocated for since taking office.

Bill will be visiting community planning groups throughout the city in the coming months, and Sherri encourages residents to take the opportunity to meet him, share your goals and ideas for the planning of your community and learn more about his vision for San Diego's future.

Upgrades to La Jolla Shores Sewer Pump Station completed



This July, the upgrades to Sewer covered major problems with Pump Station 27 in Laureate Park on Avenida de la Playa in La Jolla Shores were completed.

In 2006, the pump station was first upgraded. Prior to those improvements, this station had a history of problems with wastewater spills during its 30 years in operation.

the new pumps, including severe vibration issues. In January 2011, the pumps failed and emergency backup pumps had to be used.

The city determined that the pumps needed to be replaced with new pumps to enhance their reliability. As a result, the city started an upgrade project in the fall of 2012 that was

completed in July 2013 and cost approximately \$1.5 million.

With the new upgrade, wastewater spills in the busy La Jolla Shores business district should be a thing of the past.



New crosswalk at Colima

When the traffic roundabouts were installed along La Jolla Boulevard in Bird Rock in 2006, they featured crosswalks that used a new technology called in -pavement flashing pedestrianactivated lights. These lights

had not been used in many places in San Diego prior to that

These flashing crosswalk lights

are activated whenever a pedestrian pushes a button on the sign next to the crosswalk. The lights enhance pedestrian safety by creating good visual warnings for drivers, especially at night.

Unfortunately, the early generation version of the crosswalk lights that were installed at the Midway and Colima

roundabouts were prone to malfunctions.

This spring, the city replaced the malfunctioning inpavement flashing lights at the Midway and Colima crosswalks with new lights that should last for many years to come.
