San Diego hosts Binational Economic Development Meeting



San Diego and Tijuana Councilmlembers gathered for a binational economic development meeting.

On September 24, San Diego and Tijuana officials convened at City Hall for San Diego's first-ever binational meeting between the San Diego Economic Development Committee and the Tijuana Economic **Development Commission.**

As Chair of the Economic Development Committee, Sherri organized this historic meeting to spur cooperation and collaboration between both cities in an effort to better position our region as a worldwide economic powerhouse.

Sherri said, "I've long been passionate about boosting economic development on both sides of the border, promoting the burgeoning binational megaregion and growing the area as the hub for innovation."

The meeting featured presenta-

tions from organizations on both sides of the border and focused on the need for better collaboration among the academic and business communities with elected officials in promoting the San Diego-Tijuana mega-region.

Afterward, elected officials from Tijuana and San Diego participated in a roundtable with local companies that have operations on both sides of the border, where they discussed how to better take advantage of the skilled workforce in the region.

Development Services Dept. Unveils New Website



As part of the city's ongoing efforts to provide more userfriendly online services, the **Development Services Depart**ment (DSD) will now provide online access to permitting data.

Using Google Maps, the city's new OpenDSD website uses a software system to manage and track land development permit processing functions. The public will be able to search online

for information about projects and permits, either by address, by project number, or by using the mapping feature.

Available information includes all permit and code enforcement data, permit application information, project descriptions, project status, inspection outcomes, permit types needed, sign-offs from staff, expected fee amounts and staff contact information.

In December, businesses seeking San Diego permits will be able to use OpenDSD to pay and schedule inspections online.

The new website will give the public a better understanding of past, present and future development activity and allow community members to conduct their own research on neighborhood projects and code enforcement issues.



Our office is continuing to work with the La Jolla Shores community as well as City engineers on the Avenida de la Playa construction projects.

The projects involve a series of upgrades to the storm drains, sewer and water mains along Avenida de la Playa, which is the main business district in La Jolla Shores, along with surrounding residential streets.

The first phase of the Avenida

de la Playa storm drain project opened while crews are not is still on track to be completed before Thanksgiving.

Avenida de la Playa Infrastructure Project Update

After phase one, the closed portion of Avenida de la Playa, between Camino Del Sol and Calle de la Plata, will be reopened.

The remaining two phases of work on Avenida de la Playa will not require a 24-hour curbto-curb street closure, and will allow for the street to be reworking.

City staff will continue to work closely with business owners and residents to reduce the project's impact on the community.

All businesses will remain open during construction, and we encourage you to please visit to check out all the great things the La Jolla Shores business district has to offer.



Bring Your Own Bag: State Passes Plastic Bag Ban

On September 30, Governor Brown signed into law SB270, a bill that will phase out single-use plastic bags in California.

Sherri has long been an advocate of reducing plastic bag use in San Diego and had sought to pass an ordinance restricting their use in our city, so she is pleased that this bill has been passed and will take effect statewide.

The costs to deal with plastic bag litter at our beaches, bays and in our landfill and storm drains amounts to millions of dollars spent every year.

This new law seeks to reduce these costs by prohibiting single -use plastic grocery bags in supermarkets and drugstores starting July 1, 2015. By July 1, 2016, smaller grocery stores

and convenience stores will also need to comply with the new law. Paper bags will be available for a 10 cent charge.

Sherri will continue to partner with the City's Environmental Services Department and local businesses on a series of reusable bag giveaways in the coming months as we transition from plastic bag use.
