**Today I and my fellow Council members supported the Mayor’s proposal to address the City’s huge pension deficit by using guaranteed tobacco revenue funds to obtain \$100 million in bond funds in the next few weeks to use towards our pension deficit.**

When I assumed office the pension deficit was one of my top priorities and it was clear to me that it will take a multi-pronged approach to address it. This is a step in the right direction. However, it's pretty clear to me that it is a small step for a very long trek that we have to take. And I think that it's pretty important to point out that just refinancing our debt is not going to get us there. We will be looking at other financing mechanisms and strategies to finally resolve this issue, appropriately fund the pension system, and get this City on solid financial ground. I look forward to working with you, the Council and Mayor as we proceed in the coming months to bring forth proposals to address the pension deficit and accomplish our mutual goal of providing efficient and effective City services that improve the quality of life of all residents.
