WEEKLY UPDATE MAY 8, 2006

I am pleased and excited to announce that today I was joined by City Attorney Michael Aguirre, Deputy City Attorney Makini Hammond, San Diego Police Captain Robert Kanaski, Senior Vice President of the Recording Industry Association of America, and Anthony Rosario of the Motion Picture Association of America to announce an injunction against Fam Mart.

This indoor swap meet has created a serious problem in our community for years by allowing the sale of illegal DVDs and cassettes, illegal CDs, and counterfeit designer clothing. The sale of these items both indoor and outside in the parking lots around Fam Mart were an attraction for gang members, gang activity, criminal behavior which included shootings and stabbings, drug sales, and organized efforts to deprive legitimate businesses in the community of an opportunity to sale legal merchandise to the community.

This injunction is the result of an undercover operation and raid on Fam Mart which I announced to you in November, 2005. This raid resulted in the owner and (14) vendor owners and clerks being arrested on counterfeiting charges. Working with the City Attorney's office, a civil lawsuit was filed against Fam Mart for unlawful business practices and nuisance activities.

I commend and thank Mike Aguirre and Makini Hammond for following up on this raid and getting an injunction that requires the owners of Fam Mart to install an internet video camera system accessible to San Diego Police and have licensed security guards to ensure that illegal activity such as

counterfeit sales, drug sales, gang activity, gambling, and loitering does not occur either inside or outside of the premises.

This is a first for the City of San Diego and we are sending a message that we want responsible and ethical businesses operating in our communities and that businesses have a responsibility to ensure that their customers are able to park and shop in a safe environment to the maximum extent possible.

Northgate Gonzalez Market, the newest grocery store opening up in our communities is joining with SEDC to make a special effort in our community to hire employees that live in the 4th District.

They will be hosting a job fair on Saturday, May 13th from 8:00 am to 12:00 noon at the Southcrest Park Plaza, 43rd street and I-805. Please come with a valid picture ID, resume (if you have it), and (3) personal references. This is an excellent employment opportunity for youth and adults and I strongly encourage you to take advantage of this opportunity.
