#### Proposed Traffic Signals on College Ave. at Arosa/Soria & Adams Avenue By Carl Luster

Residents of El Cerrito will have a chance to discuss a proposal for two new traffic signals on College Avenue and vote on a letter of support at the December 17<sup>th</sup>, ECCC meeting and Pot-luck Dinner. The proposal is to install signals on *College Avenue at Arosa Street & at Adams Avenue*. If approved, the letter included at the end of this article, will go to the College Area Community Council & the Crossroads Redevelopment Project Area Committee as the ECCC input for recommendations to approve these signals and provide funding.

In response to concerns that a proposed traffic signal at *College Avenue and Arosa Street will direct too much traffic down Soria Drive, a second new signal has been proposed for the intersection of College Avenue and Adams Avenue.* A new signal at Adams would give drivers the chance to turn left into and out of El Cerrito along College Avenue without driving down Soria, which connects Arosa and Adams.

The City of San Diego has already approved, but not funded, a signal for the College & Arosa intersection, on a stretch of College Avenue with a history of accidents.

Although a new signal at Adams has not been approved by the City, this idea was presented to the College Area Community Council Project Review Committee on November 4, as an option for reducing the impact of the Arosa Street signal on the residents of Soria Drive. The Project Review Committee will reconsider the Arosa Street signal in January, after the City has a chance to study a signal at Adams and the surrounding communities have a chance to respond to the proposal for two new signals on College Avenue.

#### Proposed Letter of Support:

To: The College Area Community Council, & to the Crossroads Redevelopment Project Area Committee:

"The purpose of this letter is to help improve safety for everyone along College Avenue, in the vicinity of Arosa Street & Adams Ave, without reducing safety or degrading the quality of life on surrounding residential streets.

The El Cerrito Community Council requests the City of San Diego to install traffic lights at the intersections of Arosa Street & College Avenue & also at Adams Avenue and College Avenue to improve safety; traffic flow into & out of the surrounding residential neighborhoods. The intersection at Adams & College requires a traffic signal in its own right to ensure the safety of pedestrians & drivers on the streets west of College Avenue & north of El Cajon Boulevard. In addition, a signal is needed at Adams Avenue, in order to reduce the excess traffic diverted through Soria Drive by a signal at Arosa Street, keeping traffic where it now flows on Adams.

The El Cerrito Community Council urges that the funds be made available immediately to start construction, as soon as possible, on traffic lights at both Arosa Street & Adams Avenue, as one comprehensive approach to improving safety & traffic flow along this section of College Avenue."

# Update on the Plasma Center – Dayton/Gilbert & Berting Streets

As presented by Dale Bankhead, Asst. Director of Government and Media Relations, during November's ECCC meeting, the Family Health Centers of San Diego had the opportunity to revisit keeping the Octapharma Plasma Center as a tenant, and the Plasma Center chose to permanently cease operations at 4402 Dayton ST effective on November 19th.

"It is my pleasure to share what I believe is outstanding news for all residents of El Cerrito, especially with the residents of Dayton Street, Berting Street and Gilbert Drive.

For many years, the Plasma Center located at 5454 El Cajon Blvd. has been blight on the community due to the high volume of clients who neither lived in the area nor, as they demonstrated through their bad behavior, cared about the neighborhood.

Recently, the property was sold to Family Health Centers of San Diego (FHCSD). Subsequently, FHCSD received many complaints of illegal activities in the adjoining parking lot and the lot was closed to Plasma Center use. The unintended consequence of closing the parking lot was that the unacceptable behavior (parking congestion, littering, trespassing, loitering and other illegal activities) was driven deeper into the neighborhood, impacting the quality of life and safety of all the residents.

When this situation came to my attention, my office, in conjunction with residents, the El Cerrito Community Council, the City's Neighborhood Code Compliance Division, and the Police Department, immediately set out to resolve these very serious issues with FHCSD. As a final outcome of FHCSD's negotiations with the Plasma Center, the center closed for good on Thursday, November 19, 2009. The parking lot will remain inaccessible until FHCSD opens its community clinic sometime in the future.

Please accept my profound thanks for your assistance and perseverance as we worked with the all the parties mentioned above to resolve the situation. As your Councilmember, you have my commitment to work with you in the future to eliminate situations like this which degrade your quality of life. It is my hope that the relocation of the plasma center and future opening of the FHCSD clinic will greatly enhance your neighborhood over the long term.

**Community Plans**: The community plans are a part of the Land Use Element of the General Plan. Community plans provide more detailed land use designations and sitespecific policy recommendations than the General Plan. Community plans typically address community

- 1. Local Street and transit network
- 2. Distinctive environmental characteristics
- 3. Community landmarks
