Installation of 7,260 linear feet of 12-inch and 2,480 linear feet of 8-inch polyvinyl chloride (PVC) reclaimed water transmission pipelines including 1,400 linear feet of 4-inch PVC reclaimed water distribution lines to link the transmission pipelines with nine irrigation meters, located within the Carmel Valley and Pacific Highlands Ranch Communities. ITEM -8: **LOS PENASQUITOS RECYCLED WATER PIPELINE
