Conditional Use Permit for an existing wireless communication facility consisting of three 25-foot tall light poles, each supporting one panel antenna concealed within a 7-foot long radome. Associated equipment is located within a 208-square foot block enclosure. The project is located in the parking area of La Jolla Presbyterian Church at 6551 Soledad Mountain Road in the RS-1-2 zone. The previous permit, 95-0350-252 expired on April 24, 2013. Exempt from Environmental. Report No. HO-15-046.
