ACCEPTANCE OF DONATION - 100 CARP (KOI) FOR BALBOA PARK LILY POOL Background: (double space)

Mr. Robert O. Peterson proposes to donate 100 carp (Koi) to the City of San Diego for display in the 240,000 gallon lily pool adjacent to the Botanical Building and Casa del Prado in Balboa Park. The estimated value of these highly ornamental fish is \$5,000.

The moving and placing of the carp into the Balboa Park lily pool will be accomplished by the Scripps Institute of Oceanography, at no cost to the City. The carp are compatible with the existing plant and fish life and the total gallonage of the pool is sufficient to maintain the additional fish.

The proposed addition of the carp to the lily pool, a main focal point in the central area of Balboa Park, will add considerably to the beauty of the pool and the uniqueness of Balboa Park.
