



SUBJECT: Waiver of Rental Fee for Use of Casa del Prado

On November 27, Mr. Merle G. Coady appeared before you requesting a waiver of rental fees for use of the Casa del Prado auditorium on December 20. Mr. Coady wishes to use the facility for a concert by the Optimist Youth Band, Inc. The regular rental fee is \$195. The proposed concert has a twofold purpose:

- 1. To raise funds for their trip to the Calgary Stampede in Calgary, Canada, in the summer of 1975. While appearing at the Calgary Stampede, they will be representing the City and County of San Diego (Council Resolution #211602, September 19, 1974).
- 2. To provide an opportunity for the Band to hone their skills before a live audience.

On March 31, 1974, the Optimist Youth Band, Inc., presented a similar concert in the Casa auditorium and the Council did waive the rental fee at that time.

In view of the fact that the Optimist Youth Band will be appearing in the Calgary Stampede as a representative of the City, it is felt that approval is appropriate for their request of a second waiver of fees for the use of the Casa del Prado.

## RECOMMENDATION

It is recommended that the Casa del Prado auditorium be made available to the San Diego Optimist Youth Band without charge.
