

Funds were provided in the Capital Outlay budget of the Park and Recreation Department to make available a construction crew for the landscape development of new Park and Recreation areas. The work program for the current year sets up some 12 projects among which provision is made for the landscape development of portions of the Morley Field area.

The first project at Morley Field will be the landscape development of the area adjacent to the new Tennis Club House and, in order to implement this project, it will be necessary to have a resolution adopted by the City Council in some such form as follows:—

WHEREAS, The Park and Recreation Department of the City of San Diego has recommended the landscape development of the area adjacent to the Morley Field Tennis Club House, as shown on a landscape development plan submitted to the City Manager; and

WHEREAS, The City Manager has submitted estimates for said work and has indicated that the same can be done by the Park and Recreation Capital Outlay Construction Crew more economically than if let by contract; NOW, THEREFORE,

BE IT RESOLVED, By the Council of the City of San Diego as follows:

That the City Manager of said City be and he is hereby authorized and empowered to do all the work in connection with the landscape development of the area adjacent to the Morley Field Tennis Club House at Balboa Park in the City of San Diego by appropriate City forces in accordance with his said recommendation.
