





Sec 1st No person under the penalty of one hundred dollars shall pursue any calling or transact any business hereinafter provided for without a license, and any person refusing to exhibit such license when required to do so by the City Marshal or any other duly authorized person shall be subject to a fine of fifty dollars.

Sec 2d All persons desiring a license to pursue any of the callings provided for in this ordinance, shall state to the Tax Collector under oath to which of the following classes in his opinion, the extent of his business property attaches him. If the Tax Collector has no reason to doubt his statement he shall be enumerated in that class upon the payment of the amount assessed upon such class, according to the following schedule: - The Tax Collector shall give him a receipt for the same in duplicate, and upon the presentation of one of such receipts to the Clerk of the Common Council (whose duty it shall be to file such receipt) the Clerk shall issue a license to such person or persons, authorizing him or them to exercise the business, trade, or occupation, for the period for which they have paid, and for each certificate or license so issued, the Clerk shall be entitled to receive one dollar from the party or parties taking out such license, and such license may be received from quarter to quarter upon handing over to the Clerk a duplicate receipt as above prescribed, and paying him fifty cents for every such renewal.

Sec 3d The following shall be the form of license --- Know all men by these presents that ______having applied for a license to pursue the calling or business of a merchant, auctioneer, grocer, butcher, baker hotel or tavern keeper, or keeping a restaurant or of vending, bartering, selling, exchanging, or otherwise disposing of liquors of any kind in any quantity less than a quart; or of keeping a monte bank, faro bank, roulette table, or other table, billiard table or nine or ten pin alley; or of giving an exhibition of theatrical or circus performances or of any other public amusement; or of driving a dray, cart, wagon, or other public vehicle for the transportation of passengers or goods as the case may be -- in a house, room, shed, tent, or other place, as the case may be -- situated (describing the location of the house, room, shed, tent, or other place) of which said house, room, shed, tent, or other place) of which said house, room, shed, tent, or other place Mr______ is the agent or owner; Now this is to certify that the said ______ has permission by this license, in accordance with the provisions of a city ordinance passed by the Council and approved by the Mayor on the _____day of ______ month 1850, to pursue the calling or business of (specifying as above) for the space or term of (giving the term up to the end of the quarter) he paying for the said license at the rate of \$_____ per month, payable always in advance.

Section 5th All persons or proprietors keeping or desiring to keep a monte bank, faro bank, roulette table or other table, at which any game of hazzard, chance or skill, are or shall be played or exhibited, whether with cards, dice, or any other invention, device, or instrument whatsoever, shall pay for every such license the sum of \$35 per month for each and every kind of game so kept or exhibited.

Section 6th All persons or proprietors keepingror desiring to keep a billiard table, or nine or ten pin alley, shall pay for every license the sum of \$10 per month for each and every table or alley so kept.

Section 7th All persons vending, bartering, selling, exchanging or otherwise disposing of liquors of any kind in any quantity less than one quart, to be drank when sold, shall be divided into three classes of whom all those having a capital invested to the amount of \$1000 or more shall constitute the first class -- all those having a capital invested to the amount of \$500 or more shall constitute the second class, and all those having a capital invested to an amount less than \$500 shall constitute the third class. The first class shall pay for a license the sum of \$30 per month, the second class the sum of \$20 per month, and the third class the sum of \$15 per month.

Section 8th All persons pursuing the trade or calling of a hotel or tavern keeper, or all persons keeping a restaurant shall pay for a license the sum of \$15 per month for a hotel or tavern, and \$5 per month for a restaurant.

Section 9th All persons giving theatrical or circus performances, or any other exhibition for public amusement, shall pay for a license the sum of ten dollars for each and every exhibition.

Section 10th All persons owning drays, carts, wagons, or other public vehicles for the transportation of passengers or goods as the case may be, shall pay for a license the sum of \$1 per month for each and every vehicle so used.

Section 11th All taxes provided for in this ordinance shall be paid invariably in advance on the 1st day of January, April, July and October and all licenses taken out at any intermediate period shall be paid for up to the commencement of the next quarter.

Section 12th Ordinance No.16 adopting the ordinances of the

Ajuntamiento, and all licenses heretofore issued shall be null and void.

Creating the office of City Surveyor and defining his duties.

Be it Ordained by the Mayor & Common Council of the City of San Diego;-

<u>Section 1st</u> That the office of City Surveyor be & is hereby created.-<u>Section 2nd</u> It shall be the duty of the City Surveyor before entering upon the discharge of the duties of his office, to take and subscribe the Oath of Office and give bond and sufficient sureties in the sum of <u>Five thousand dollars</u>, payable to the Mayor & Common Council in the form prescribed by the Ordinance concerning the official bonds of officers, conditioned for the faithful performance of the duties of his office.-

<u>Section 3rd</u> He may appoint one or more deputies, who shall, before entering upon their duties, take the oath of office, which shall be endorsed upon their appointment.- The appointment shall be in writing, signed by the Surveyor and given in duplicate, one of which shall be filed in the office of the Clerk of the Common Council, and such appointment may be revoked at will, by writing, filed in the same office.- The Surveyor and his sureties shall be liable for all the official acts of his deputies.-

<u>Section 4th</u> For any official act, or any omission to perform any duty imposed upom him by Law, the Surveyor shall be liable on his bond to any person injured, and he may, on the representation of the Mayor and upon sufficient cause, be removed from office by the Common Council.-

<u>Section 5th</u> It shall be the duty of the City Surveyor, by himself or deputy, to execute any survey that may be required by this Corporation, and upon the application of any individual he shall also execute any survey, on his payment of <u>five dollars</u> for each lot, having four corners.

<u>Section 6th</u> It shall be the duty of the City Surveyor to keep a correct and fair record of all the surveys made by himself or deputy, in a bound book, to be provided by the Council for that purpose, which book shall be transmitted to his successor in office; he shall also number such surveys progressively and shall preserve and file: a copy of the field notes and calculations of each survey, endorsing thereon its proper number, a copy of which and also a fair and accurate plot, together with the certificate of survey, shall be furnished by him to any person requiring the same, upon payment of the fees allowed by Law.-

<u>Section 7th</u> It shall be the duty of the City Surveyor, in all surveys, to express the courses according to the true meridian, and the variation of the magnetic meridian from the true meridian shall be expressed on the plot, with the year, month and day of the survey.-<u>Section 8th</u> It shall be the duty of the City Surveyor to report to the Common Council at the first regular meeting in January, April, July and October, a full and correct statement of his official acts during the guarter preceding and in this report he shall communicate all and every information which may be in his possession concerning surveys made by him or other matter connected with the duties of his office.-<u>Section 9th</u> It shall be the duty of the City Surveyor to communicate to the Common Council, all and every information which may come into his possession from time to time, which may involve the interests of the City, or where required by them so to do and he shall perform such other duties, appertaining to his office, as may be required of him from time to time by the Council.-







Sec. 1st. That the office of City Surveyor be and is hereby created.

Sec. 2d. It shall be the duty of the City Surveyor before entering upon the discharge of the duties of his office, to take and subscribe the oath of office and give bond with sufficient sureties in the sum of five thousand dollars payable to the Mayor & Common Council in the form prescribed by the Ordinance concerning the official bonds of officers conditioned for the faithful performance of the duties of his office.

Sec. 3d. He may appoint one or more deputies who shall before entering upon their duties take the oath of office which shall be endorsed upon their appointment. The appointment shall be in writing signed by the surveyor and given in duplicate one of which shall be filed in the office of the Clerk of the Common Council, and such appointment may be revoked at will by writing filed in the same office. The Surveyor and his sureties shall be liable for the official acts of his deputies.

Sec. 4th. It shall be the duty of the City Surveyor by himself or deputy, to execute any survey that may be required by the Corporation, and upon the application of any individual he shall execute any survey on his payment of five dollars for each kind of lot.

Sec. 5th. For any official act or any mission to perform any duty imposed on him by law, the Surveyor shall be liable on his bond to any person injured, and he may upon the representation of the Mayor and upon sufficient cause be removed from office by the Common Council.

Sec. 6th. It shall be the duty of the City Surveyor to keep a correct and fair record of all the surveys made by himself or deputy, in a bound book to be provided by the Council for that purpose, which book shall be transmitted to his successors in office.

He shall also number such surveys progressively and shall preserve and file a copy of the field notes and calculations of each survey, endorsing thereon the proper number, a copy of which and also a fair and accurate plat together with the certificate of survey shall be furnished by him to any person requiring the same upon payment of the fees prescribed by law.

Section 7th. It shall be the duty of the City Surveyor, in all surveys, to express the courses according to the true meridian, and the variation of the magnetic meridian from the true meridian shall be expressed with the day, month and year of the survey.

Sec. 8th. It shall be the duty of the City Surveyor to report to the Common Council at their first regular meeting in the months of January, April, July and October, a full and correct statement of all his official acts during the preceding quarter and in this report he shall communicate all and every information which he may have in his possession concerning surveys made by him, or other matter connected with the duties of his office.

Section 9th. It shall be the duty of the City Surveyor to communicate to the Common Council all and every information that may come into his possession from time to time, which may involve the interests of the City, or when required by them so to do, and he shall perform such other duties appertaining to his office, as may be required of him from time to time by the Council .

Section 10th. It shall be the duty of the City Surveyor to make a correct copy of the maps of the town and plazas of San Diego as made by Lieut. Cave J. Couts of the United States Army and now on file in the office of the Clerk of the Common Council, which maps he shall keep in his office for his own use and for public reference.
