

# EPA Certified Renovator Training



Effective April 22, 2010, contractors who conduct home improvement activities in housing built prior to 1978 and child occupied facilities must be certified in accordance with the new EPA Renovation, Repair, and Painting (RRP) rule.

Common renovation activities like sanding, cutting, and demolition can create hazardous lead contamination which is harmful to adults and children. The new EPA RRP rule requires "Certified Renovators" be assigned to each project and ensure specific work practices are followed to reduce the risk of lead poisoning to both the workers and occupants who are subject to these types of renovation activities. The use of lead-safe work practices are already required to be used.



The City of San Diego Environmental Services Department is offering EPA's Certified Renovator Training. Upon completion of the course and passing the test at the end of the one-day training, attendees will receive EPA certification as a Certified Renovator. The cost is \$135 per person.
