ACCEPTANCE OF SPECIAL WASTES AT MIRAMAR LANDFILL	E-001-95	MARCH 1, 2000

Authority:

Section 66.0124 of the San Diego Municipal Code delegates the supervision of refuse collection, transportation and disposal to the City Manager and authorizes the promulgation of rules and regulations regulating such collection, transportation and disposal.

Section 66.0129 of the San Diego Municipal Code authorizes the City Manager to establish refuse disposal fees with the intent of recovering the full and complete costs associated with operating refuse disposal facilities; and to include fees necessary for any waste which, because of its physical or chemical characteristics, requires special procedures to ensure proper disposal.

Definitions:

Department means the Environmental Services Department of the City of San Diego.

Designated Waste has the same meaning as in the California Code of Regulations, Title 27, Division 2, Subdivision 1, Chapter 3, Subchapter 2, Article 2, Section 20210.

Director means the Environmental Services Director of the City of San Diego or the Director's duly designated representative.

Generator means any person whose act or process produces a waste.

Hazardous Waste has the same meaning as in the California Code of Regulations, Title 22, Division 4.5, Chapter 11, Article 1, Section 66261.3.

Industrial Solid Waste has the same meaning as in the California Code of Regulations, Title 27, Division 2, Subdivision 1, Chapter 2, Article 2, Section 20164; "Industrial Wastes include all types of solid wastes and semi-solid wastes which result from industrial processes and manufacturing operations."

Person means an individual, corporation, partnership, association, non-profit organization or governmental entity.

Special Waste means solid waste which, because of its physical or chemical characteristics, requires special procedures to ensure proper disposal.

Special Waste Disposal Request means the form designated and provided by the Environmental Services Department for requesting the disposal of special wastes.

Special Waste Manifest means the form designated and provided by the Environmental Services Department for documenting the disposal of special wastes.

Policy:

The Miramar Landfill will accept for disposal special wastes in accordance with procedures that ensure the safety of employees and protection of the environment.

The disposal of these wastes will be subject to special fees as provided for in the approved disposal fee schedule. The fees are established to recover the costs associated with the special waste disposal procedures.

Regulations:

The following regulations for the acceptance of special wastes at the Miramar Landfill are hereby established, and it shall be unlawful for any generator to dispose of such wastes in a manner contrary to these regulations.

I. GENERAL:

A. Intent and Purpose.

The intent and purpose of the City Manager in promulgating these regulations is to provide for the effective and efficient administration of the acceptance process for special wastes; to provide a means to track and document the acceptance of these wastes; to provide necessary protection for the health and safety of Landfill employees and Landfill users; and to provide necessary protection for the environment.

B. Authority of Environmental Services Director.

The administration of the acceptance process for special wastes is under the control of the Director, who shall have the authority to require the submission of such forms, manifests, documentation and other information by generators, as needed, in order to implement the intent of these regulations.

C. Notices.

All applications, notices or reports required to be given or served upon the City by these regulations shall be given by letter deposited in the United States mail, postage prepaid, addressed to the City of San Diego Environmental Services Department, Environmental Programs Division, Attention: Hazardous Substances Enforcement Team, 9601 Ridgehaven Court, Suite 320, San Diego, CA 92123-1636.

D. Failure to Comply

Any generator who fails to comply with these regulations shall be subject to administrative fees and actions as specified by the City Manager.

E. Effective Date.

These regulations shall be in full force and effective as of April 1, 2000.

II. ACCEPTANCE CRITERIA

A. General

1. The Miramar Landfill accepts special wastes generated within San Diego city limits and from other designated jurisdictions. These wastes are accepted Monday through Friday, excluding designated holidays, between the hours of 7:00 a.m. and 2:00 p.m, with prior approval and advance scheduling.
2. Documentation, as required in the specific acceptance criteria, shall be received a minimum of two (2) working days prior to the requested disposal date. Approval is required prior to scheduling disposal.
3. All approved special waste loads shall be scheduled for disposal no later than 9:00 a.m. the day prior to disposal.
4. A Special Waste Manifest shall be completed for each load and will accompany the load at the time of disposal.

B. Non-Friable Asbestos Waste

The acceptance criteria for non-friable asbestos waste is included as Attachment 1.

C. Contaminated Soil

The acceptance criteria for contaminated soil is included as Attachment 2.

D. Treated Wood Waste

The acceptance criteria for treated wood waste is included as Attachment 3.

E. Industrial Solid Waste

The acceptance criteria for industrial solid waste is included as Attachment 4.
