Do you perform repairs, maintenance, painting, rehabilitation, remodeling or renovation in housing or structures built before 1979? Construction related work on pre-1979 structures can cause exposure to toxic levels of lead for your workers and the occupants. Lead-Safe Work Practices are easy to incorporate into all construction means and methods. The City of San Diego also has a new Lead Hazard Prevention and Control ordinance. This ordinance also make it illegal to create a lead hazard and requires lead safe work practices when disturbing lead-containing paint in the City of San Diego. The City of San Diego is strictly enforcing these new laws. Learn how to stay in compliance!

The City of San Diego Environmental Services Department is offering a Lead-Safe Work Practice training course. By taking this HUD/EPA-approved course and passing the test at the end of the one-day training, you will receive a notice of completion certificate stating that you are trained in lead safe work practices and you will also receive a free 200 page plus reference manual.

Being trained in lead-safe work practices gives you a competitive edge in bidding jobs.

This course **IS NOT** for certification or licensing of lead inspectors, risk assessors, abatement supervisors, or abatement workers.
