

# CITY OFFICIALS: CITY AGENCY OFFICERS

This list contains the names of “City Officials” employed by the City’s agencies (Centre City Development Corporation, San Diego Convention Center Corporation, San Diego Data Processing, San Diego Housing Commission, and Southeastern Economic Development Corporation). It is intended for guidance only. Because it is not updated daily, it may not contain the name of every agency officer or employee who is considered a “City Official.” If you have lobbied someone and are not sure if he or she is a “City Official,” you are strongly encouraged to contact that person directly to see if his or her title is listed in the Lobbying Ordinance’s definition of “City Official.” Consult the Lobbying Ordinance or the Ethics Commission’s “Fact Sheet: Am I a Lobbyist?” for the list of “City Official” titles.

Note: this list does not contain the names of the City’s elected officers or unclassified employees who are also considered “City Officials.” The Ethics Commission maintains a separate list of these individuals. This list also does not contain the names of the members of the City’s boards, commissions, and committees who are “City Officials.” Note, however, that every individual serving on a Board of Directors for one of the City agencies is a “City Official.” For the other City boards, commissions, and committees whose members are “City Officials,” please refer to the separate list maintained by the Ethics Commission.
