Because it is only updated quarterly, it may not contain the name of every unclassified officer or employee who is considered a "City Official." If you have lobbied someone and are not sure if he or she is a "City Official," you are strongly encouraged to contact that person directly to see if his or her title is listed in the Lobbying Ordinance's definition of "City Official." Consult the Lobbying Ordinance or the Ethics Commission's "Fact Sheet: Am I a Lobbyist?" for the list of "City Official" titles.

Note: this list does not contain the names of "City Officials" employed by the City's agencies (Centre City Development Corporation, San Diego Convention Center Corporation, San Diego Data Processing, San Diego Housing Commission, and Southeastern Economic Development Corporation).
