Speaker Melvin Shapiro recommended that under section 26.0422, Item 4, the word "solely" be added to the sentence to read: "The complaint is based 'solely' on speculation, opinion . . . ." Mr. Shapiro added that when a person makes a complaint , generally there would always be a certain amount of speculation. However, if there is evidence accompanied with the complaint, then there should be an investigation.
