The Carmel Valley Maintenance Assessment District (District) was established in July 1987 to provide maintenance for landscaped medians, paved medians, landscaped rights-of-way, slopes, mini-parks, community parks, and open space within the District boundaries. The District maintains 4.91 acres of landscaped medians, 3.40 acres of paved medians, 6.99 acres of landscaped rights-of-way, 48.66 acres of landscaped slopes, 5.63 acres of revegetated native perimeter slopes, 39.42 acres of mini parks, 56,718 linear feet of gutters and brow ditches, 6.72 acres of sidewalks, 1.08 acres of freeway easements, and 81.14 acres of open space. Through a contribution from the General Fund, the District maintains the frontage of Carmel Valley Fire Station #24 at the intersection of Del Mar Heights Road and El Camino Real.

The Carmel Valley Community Planning Committee approved the Annual Fiscal Year 2005 Budget on April 13, 2004. In addition, the planning committee approved increasing assessments by the 3.35% San Diego Urban Consumer Price Index (SD-CPI-U).

During Fiscal Year 2005, it is anticipated that the Carmel Valley Maintenance Assessment District will be reballoted to maintain additional assets and to construct minor capital improvements.
