The La Jolla Village Drive Maintenance Assessment District (District) was established in January 1988 to provide maintenance of 26,833 square feet of landscaped medians and 41,099 square feet of hardscaped medians along La Jolla Village Drive and Nobel Drive between Interstate 5 and Regents Road.

During Fiscal Year 2002, Fiscal Year 2003, and Fiscal Year 2004, no assessment was levied on parcels within the La Jolla Village Drive Maintenance Assessment District due to a large reserve that accumulated over the years as a result of medians being turned over by the developer later than originally scheduled. However, \$6.87 will be assessed in Fiscal Year 2005, which is the same assessment levied in Fiscal Year 2001. This assessment was not indexed by the San Diego Urban Consumer Price Index (SD-CPI-U).

The Annual Fiscal Year 2005 Budget is based on current maintenance costs. The District does not have an established advisory committee.
