The Mira Mesa Maintenance Assessment District (District) was established in July 1983 to provide maintenance of landscaped medians, slopes and streetscapes along major arterial streets and corridors within the District. Zone 1 comprises the majority of the property owners along the main thoroughfares in the District; Zone 2 consists of commercial and industrial properties in the western section of the District; and Zone 3 comprises residential developments in the northeastern area of the District.

The Mira Mesa Town Council Maintenance Assessment District Advisory Committee approved the assessments associated with the Annual Fiscal Year 2005 Budget on March 1, 2004. As a result of this action, assessments in all three zones are brought to the maximum allowable assessment. The 3.35% San Diego Urban Consumer Price Index (SD-CPI-U) is applied to Zone 3 but not Zones 1 and 2. In accordance with Resolution R-265842 adopted June 2, 1986, and City Manager's Report 086-114, the City contributed \$19,767 from the Environmental Growth Fund for the maintenance of medians.
