The Scripps-Miramar Ranch Maintenance Assessment District (District) was established in May 1981. The District maintains 15,468 square feet of landscaped medians, 3,260 square feet of paved medians, 479 acres of open space areas (including Hoyt Park, Forrestview Park, and Semillon Park), and two ponds (Evans Pond and Hendrix Pond). Through a transfer from the General Fund, the District also maintains Aviary Park, Cypress Canyon Neighborhood Park, Jerabek Neighborhood Park, Lakeview Neighborhood Park, Jerabek Elementary School Joint Use, Scripps Ranch High School Joint Use, and the Scripps Ranch Library frontage.

A group of property owners representing the Scripps Ranch Civic Association reviewed the Scripps-Miramar Ranch Maintenance Assessment District Annual Fiscal Year 2005 Budget on March 18, 2004. In addition, the property owners approved increasing assessments by the 3.35% San Diego Urban Consumer Price Index (SD-CPI-U).
