The District is located in the Talmadge neighborhood, situated between Fairmount Avenue and Collwood Boulevard, north of Monroe Avenue. Capital improvements funded by the District are identified in CIP 39-010.0, Talmadge Historic Gate Restoration, Traffic Circle, and Street Lighting Improvements, Fund 702591.

The Annual Fiscal Year 2005 Budget was approved by the Talmadge Maintenance Assessment District Advisory Committee on March 23, 2004. The advisory committee decided not to raise assessments by the San Diego Urban Consumer Price Index (SD-CPI-U).
