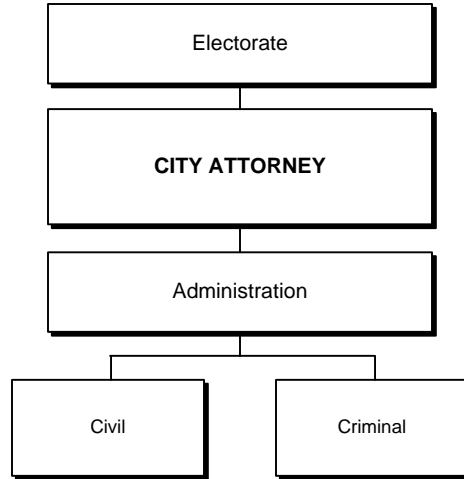
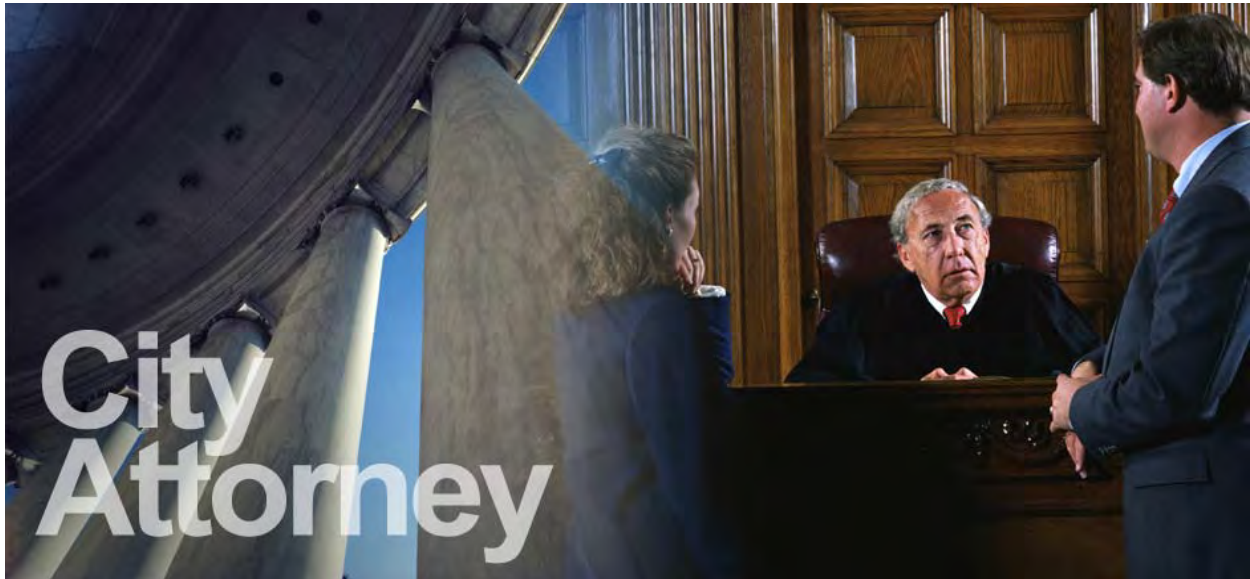

Mission Statement

In 1931, City of San Diego voters adopted a ballot measure creating an independently elected City Attorney. As a result of their decision, these voters changed the role of the City Attorney from an appointee to an elected official who is charged with protecting the interests of all San Diegans.

The City Attorney's Office serves the citizens of San Diego as both its misdemeanor prosecutor and its chief legal advisor. In the former role, the City Attorney's Office, along with the Police Department and the Fire Department, works to safeguard the public by bringing misdemeanants to justice. Crimes prosecuted by the Office include violations of City, county, and State laws occurring within the City of San Diego. In the latter role, the Office provides legal guidance to the Mayor and City Council, Council Committees, City Manager, and City Departments.

Department Description

The Office is divided into three divisions--Civil, Criminal, and Administration. The primary operations of the Office are established in the City Charter (Section 40 and 40.1) and carried out in Criminal and Civil Divisions.

- The Criminal Division provides prosecution of misdemeanor criminal offenders and proactive community-based public safety initiatives.
- The Civil Division provides legal advice to every level of City government, files lawsuits on behalf of the City, and defends lawsuits brought against the City.

The City Attorney's Office is staffed with professional, civic minded public servants. Attorneys, investigators, advocates, secretaries, legal assistants, and support staff work in highly effective teams to serve the City and the people of the State of California. The San Diego City Attorney's Office has been recognized at the local, state, and national levels for innovation, excellence, and measurable results related to efficiency, effectiveness, and public safety.

Office of the City Attorney. These services include management of personnel and human resources, financial and budgetary issues, and information and communications systems. All of these functions are essential to the effectiveness and efficiency of the day-to-day operations of the Office.

Civil

The Civil Division is led by an Assistant City Attorney who oversees division management, an Assistant City Attorney who is in charge of litigation, and an Assistant City Attorney who supervises advisory services. All of these lawyers report directly to the City Attorney. The Civil Division's primary focus is protecting the interests of the citizens of San Diego by providing the best legal advice possible to the Mayor and City Council, to Council committees, and to City departments. In addition the Civil Division provides ongoing legal guidance and support to City Council committees, the Planning Commission, the Housing Authority, and the Redevelopment Agency. The Division is divided into sections that specialize in rendering services regarding Real Property, Public Works, and Business and Government. Civil Division Deputy City Attorneys advise on subjects relating to labor and pension concerns, construction agreements and contracts entered into for City public works projects, and the acquisition, use, and regulation of City funds. The Litigation section of the Civil Division defends the City on a wide variety of legal matters, including employment, police, and land use issues and recoups City funds in plaintiff actions.

Criminal

The Criminal Division, which is led by an Assistant City Attorney reporting directly to the City Attorney, prosecutes misdemeanor offenses committed within the City of San Diego. These misdemeanors include driving under the influence of alcohol or drugs, child abuse, domestic violence, thefts, sex offenses, gang violence, quality-of-life crimes, zoning and building code violations, and consumer and environmental crimes. Prosecutors in the Screening and Arraignment, Neighborhood Prosecution, Trial, and Appellate Units handle the majority of the cases reviewed each year. Prosecutors are also assigned to one of the specialized units--Consumer and Environmental Protection, Code Enforcement, Child Abuse, and Domestic Violence. The Criminal Division ensures that people who break the law receive appropriate punishment and rehabilitation.

Service Efforts and Accomplishments

The Office of the City Attorney is proud to share with the people of San Diego a year-end review of its work, which includes the following highlights of Fiscal Year 2005:

Criminal Division

- The Criminal Division filed 35,000 cases submitted by the San Diego Police Department and other law enforcement agencies.
- Added the Public Integrity Unit, staffed by an experienced Attorney and a seasoned investigator to prosecute public corruption and campaign finance violations.
- The Consumer Environmental and Protection Unit successfully prosecuted numerous cases: 13 storm water violations, 22 illegal dumping and hazardous waste disposal situations, 12 identity thefts and filed more than 125 cases.
- The Neighborhood Prosecution Unit prosecutors work in 25 neighborhoods with the Police Department, other agencies, and community members to combat quality of life crimes. Approximately 2,500 Homeless Court cases were processed.
- The San Diego Traffic Offender Program, in partnership with the Police Department, initiated and provided oversight in the forfeiture of more than 125 vehicles from suspended, revoked, and unlicensed drivers.
- The Code Enforcement Unit's joint venture with Neighborhood Code Compliance Department and the Police Department resulted in a strong enforcement program that holds "water thieves" accountable.
- The Drug Abuse Response Team moved out of the Code Enforcement Unit in order to better focus and augment its ability to address the increasing problems with gangs and narcotics dealing.
- The Domestic Violence Unit is now handling sex crimes and is coordinating with Sexual Assault Felony Enforcement to prosecute sex offender registration violations.

Civil Division

- Established a Finance and Disclosure Team, to position the City at the forefront nationwide in reviewing and providing disclosures on securities offerings.
- Civil Advisory Division attorneys assisted the City by drafting more than 100 pieces of new legislation, including: Tenants Right to Know: Legislation to limit a landlord's ability to evict long-term tenants without just cause; Condominium Conversions: Amendments to City land use regulations to include condominium conversions in the City's mandate for inclusionary affordable housing and to require relocation payments to qualifying tenants; Lead Hazard Prevention and Control: Regulations designed to protect children from the hazards associated with peeling lead-based paint; Ballpark Residential Parking: Regulations to provide parking relief for residents of the ballpark area; and Brush Management: Revision of the City's brush management regulations in the wake of the 2003 fires.
- Part of the legal support provided is the drafting of legal memoranda on important issues facing the City including: Counting of votes for write-in candidates; SPSP/401k Trustee Board responsibility regarding investment funds; Disclosure of official calendars under the Public Records Act; Applicability of prevailing wage laws to City projects; and the federal proposal to permit the City to donate the Mt. Soledad Memorial property to the federal government.

Department Support

- Civil Advisory Deputies provided legal review on more than 900 individual matters requiring City Council action and day-to-day legal support on thousands of other matters, including: Implementation of the City Parking Task Force recommendations; Implementation by the Storm Water Division of the \$2,843,317 Prop13 Coastal Nonpoint Source Pollution Control Grant for the Chollas Creek Restoration Project; Working with airports to enhance FAA funding and to support their operations; Issuance of Multi-family Housing Revenue Bonds to facilitate the development of more affordable housing units in the City; and Updating City Council policy for Maintenance Assessment District formation to assist communities with start-up costs.

Future Outlook

At the beginning of 2005, in an effort to provide better service to and protection of crime victims, the general trial division, which handles the majority of the cases issued by the Criminal Division, transitioned to a vertical prosecution unit. Each deputy now has several weeks, rather than several hours, to talk to victims and witnesses, conduct expanded investigations, and prepare motions and trial briefs. Also, in an effort to better address both increasing gang problems and issues unique to each neighborhood, the Division hopes to expand the neighborhood prosecution unit and the Drug Abatement Response Team (DART) unit. Finally, the Criminal Division is in the process of developing an officer stand-by policy in an effort to save taxpayer money resulting in unnecessary overtime and to allow on-duty officers to remain at work until summoned to court.

The City Attorney's Office will be expanding its Civil Division work load to focus on cost recovery for the City with the goal of making the Civil Division as self-sufficient as possible. The Civil Division will also continue to provide early review, advice, and assistance to City departments.
