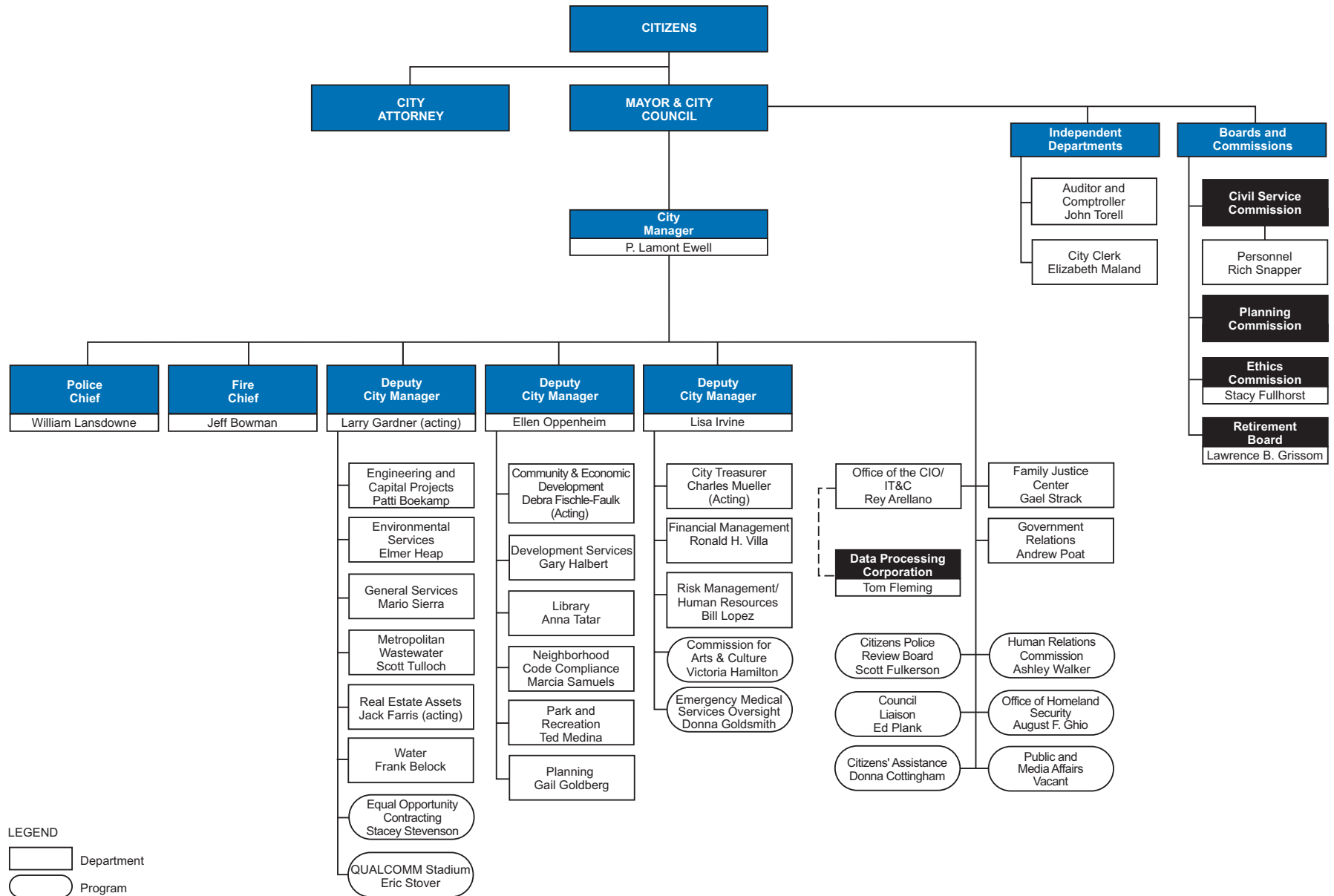
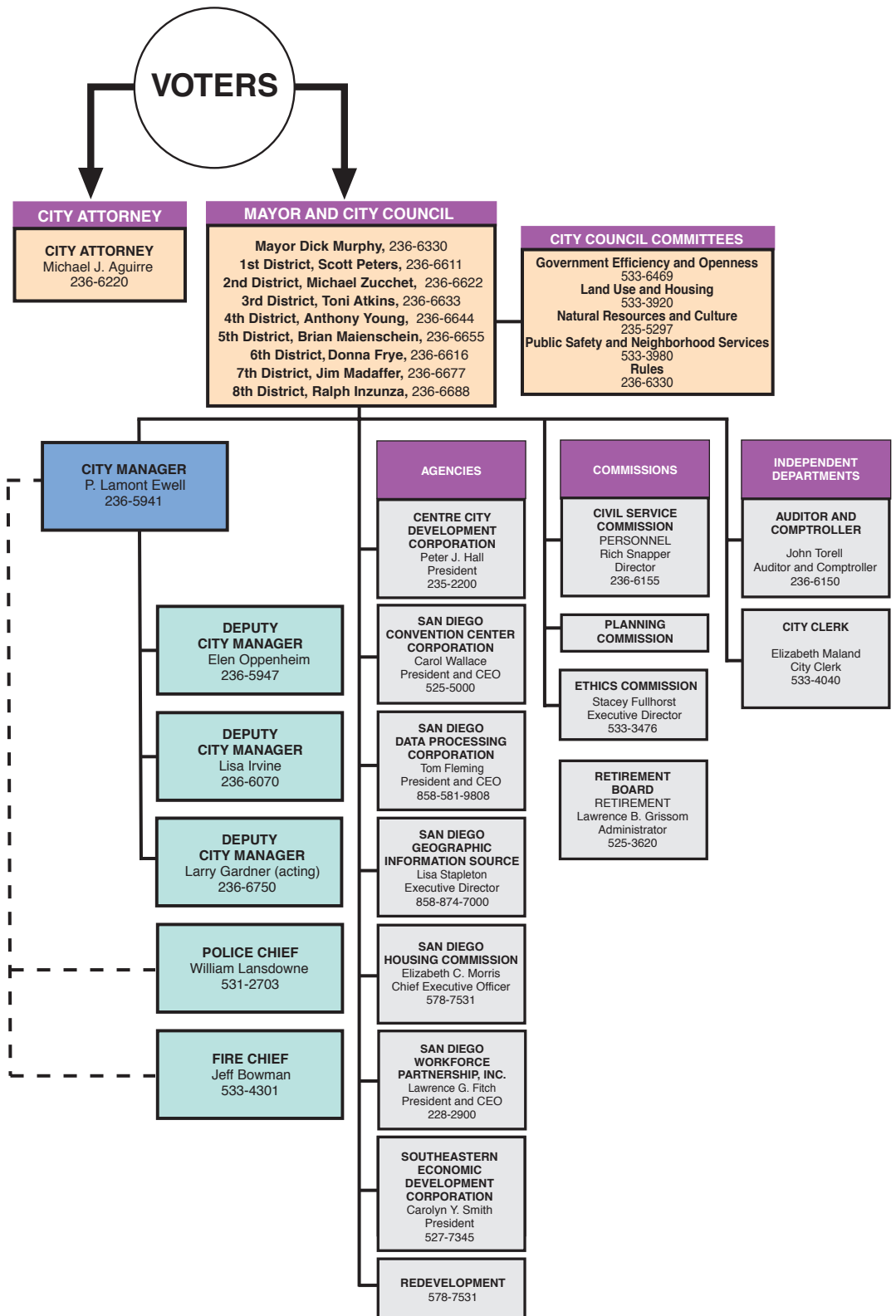




# City Organizational Structure
