This memorandum is in response to questions asked at the Budget Review Committee Meeting held on May 6, 2009. The responses are grouped by department in the order that they were reviewed by the Committee.

**Purchasing and Contracts**

**COUNCIL DISTRICTS 3 & 6**

**QUESTION:** Requested that the Mayor's office provide a comprehensive list of outside contracts valued over \$200,000.

**RESPONSE:** A comprehensive list of outside contracts valued over \$200,000 is attached to this memorandum.

**Development Services/Neighborhood Code Compliance**

**COUNCIL DISTRICT 1**

**QUESTION:** How many sustainable projects applications have you received in FY 2009 as compared to FY 2008? What is the difference in processing time for the expedite program and the regular permit processing process?

**RESPONSE:** The department had 17 sustainable projects with 213 residential units submitted in FY 2008. So far in FY 2009 the department has had 5 sustainable projects with 6 residential units. The processing time is half of what it takes normal discretionary projects to be processed.

**Development Services/Neighborhood Code Compliance**

**COUNCIL DISTRICT 4**

**QUESTION:** Regarding 2007 Wildfire Reimbursements: What amounts have already been received from the Federal Government as reimbursements for the wildfires; how much should we be receiving in the future and when will the reimbursements be received?

**RESPONSE:** The City of San Diego submitted for federal/state reimbursement for the City Council's Permit Fee Waiver Policy (DSD) and the Disposal Fee Waiver Policy (Environmental Services Department). Although Project Worksheets were submitted by the City to recover costs for both programs, the submittals were deemed ineligible. FEMA denied the City's reimbursement requests and obligated \$0 funding because the claims were considered loss of revenue.

The waiving of waste disposal fees and building permit fees, although considered disaster-related, were not recommended for funding by FEMA because they were not associated with an immediate threat to life, public safety, and improved property. Therefore, FEMA did not recommend Public Assistance funding for either project.

**Development Services/Neighborhood Code Compliance**

**COUNCIL DISTRICT 5**

**QUESTION:** Councilmember De Maio asked for a very specific memo to be provided to him answering the question of why DSD had not submitted any applications for Federal stimulus funds for graffiti control and foreclosures; to also be included in the memo is information on when DSD intends to submit such applications.

**RESPONSE:** The department has reviewed the City Funding Book for the American Recovery and Reinvestment Act of 2009 (ARRA) as prepared by the League of California Cities. The funding elements within the book do not include any specific reference to funds available for graffiti control or code enforcement related to foreclosures. Funds for other code enforcement services could potentially be provided under the Community Development Block Grant (CDBG) Program and the department is in the process of determining eligibility. However, it should be noted that Neighborhood Code Compliance already utilizes CDBG funding for limited proactive enforcement. Any further CDBG funds potentially available through the ARRA will be subject to the same focus and limitations as the existing CDBG funding. Additional funds may be considered redundant to existing programs and therefore likely disallowed by HUD. The department will confirm the availability and limitations of this type of funding and will inform the Council of the results.

**Development Services/Neighborhood Code Compliance**

**COUNCIL DISTRICT 5**

**QUESTION:** Why are fire inspection positions budgeted in DSD (through an SLA) when work is being performed in the Fire Dept? The stated concern is about transparency. Please justify this approach.

**RESPONSE:** The two vacant, Fire Inspector II positions reflected in the FY 2010 Proposed Budget were previously approved to be reclassified as Land Surveying Assistant positions, subsequent to a personnel reclassification study. The budgetary execution of the reclassification of these two positions however, is planned to occur in the FY 2011 Budget.

**Development Services/Neighborhood Code Compliance**

**COUNCIL DISTRICT 5**

**QUESTION:** How many people are in Public Information in DSD; what are they doing; why is there a need for so many Public Information positions in DSD?

**RESPONSE:** Development Services has 17.00 Public Information Clerks budgeted, 15.00 of these positions are filled. The vacant positions include 1.00 Customer Services Manager and 1.00 Supervising Public Information Officer.

The general classification specification for Public Information Clerk is listed below:

“Under general supervision, to provide specific and detailed information regarding complex government rules, policies, municipal code provisions and regulations which pertain to respective departments as a primary job function, and to perform related work.”

This position may be under filled by a Clerical Assistant II, and after 6 months can career advance to a Public Information Clerk.

In Development Services there are Public Information Clerks performing the following functions:

- 1) Issue Mechanical, Plumbing and Electrical Permits either at the counter, or for applications received via internet request or FAX. As part of this function, they issue invoices and collect credit card and check payments.
- 2) Provide Customer Check-In service. This involves setting up the visit into the computer, and knowledge of department regulations in order to direct customers to the correct service area.
- 3) Retrieve records for customer requesting land development documents. These may be paper files, or microfilm files. They also collect the copy fees from customers.

Development Services currently has 1.00 Senior Public Information Office who is responsible for media issues, customer service, DSD's internet site, and acts as an ombudsman for customers of DSD.

**Development Services/Neighborhood Code Compliance**

**COUNCIL DISTRICT 5**

**QUESTION:** Please provide a detailed description of contract accounts and an explanation of the significant increases in those accounts over the past few fiscal years.

**RESPONSE:** The dollar amounts brought up at the Budget and Finance Committee meeting were for all of Supplies and Services, which includes contracts. This dollar amount includes a range of non-personnel expenses including: office supplies, Code Books, services from outside contracts and other City departments, SANGIS, Repair of equipment, General Government Services, Rent, SAP Allocation (OneSD), Transportation Allowance and Transportation Pass Subsidy.

The major increases to Supplies and Services from the previous fiscal year are as follows, and are based on the data shown in the chart below:

- Increase in General Government Services Billing - \$350,000
- Increase in SAP Support Allocation (OneSD) - \$653,808
- Increase in Repair & Maintenance of Building (HVAC @ Ridgehaven Office) - \$30,000
- Increase in Inter-Office Mail - \$36,264

The department has \$200,000 budgeted in Engineering Services in the event that it is necessary to send out plan checks to an outside vendor.

**Development Services/Neighborhood Code Compliance****COUNCIL DISTRICT 7**

**QUESTION:** There is \$1.18 million budgeted in account 4279 (Other Non-Personnel); no money was spent from the account in FY 2009. What is the money in this account to be spent on in FY 2010? Also, please provide FY 2010 budget detail for object account 4222 (Miscellaneous Contractual Services).

**RESPONSE:** In FY09 object account 4279 was used for unanticipated charges from other City Departments including costs associated with printing and bindery services totaling \$111,002; costs associated with the annual customer survey prepared annually totaling \$60,500; increased charges for micrographic Services totaling \$65,844; repair and maintenance of building (COB) totaling \$32,654; and Legal Fees which total \$120,510.

Due to a low fund balance, the department has under expended in Supplies and Services, and may continue to do so until the department has a healthier financial position. In Enterprise Funds, even though funds may be budgeted, if the revenues are not received, Development Services strictly limits unessential expenditures.

In FY 2010, budgeted funds in object account 4279 will be used to off-set unanticipated expenditures in other object accounts and/or unanticipated project expenses that arise during the fiscal year.

**Water****COUNCIL DISTRICT 2**

**QUESTION:** What is the status of purple-pipe addition with regards to budgetary amount and account where the funds are located?

**RESPONSE:** FY 2009 budget for Reclaimed Water Projects is \$6 Million and for FY 2010 the budget is \$15.5 Million. This is new funding and does not include continuing appropriations from prior years. The initial funds are budgeted under Org 392 in object account 4279. As expenditures are required these funds are then moved to the individual projects under a CIP number and job order number and then tracked by the Capital Improvement Program analysts through the various financial systems.

**Water****COUNCIL DISTRICT 3**

**QUESTION:** How many vacancies does the Department currently have?

**RESPONSE:** There are 52.50 current vacancies in Water and 53.00 in Wastewater.

**Water**

**COUNCIL DISTRICT 6**

**QUESTION:** What's the cost of the Water Service Study and in which line item is it reflected?

**RESPONSE:** For FY 2009 and FY 2010, Water had not initially planned for a Cost of Service Study. Historically, this study is prepared when Water is preparing to go out for new water rates. The last cost of service study was done prior to the approval of the current water rates. In February 2007, Council approved water rate increases from FY 2008 through FY 2011. However, in FY 2009, the Water and Wastewater Departments signed a contract with Raftelis Financial Consultants in order to establish new water and wastewater rate models. Establishing new models was to be the first step of the longer process of reviewing rates, and eventually a cost of service study.

The new water and wastewater rate model contract was for \$500,000, of which \$370,000 was for development of the new models and \$130,000 was for additional services. The expense for this activity was budgeted for in the Miscellaneous Services and Unclassified Personnel Services line items. Due to the interest for a cost of service study to be completed prior to the ending of the currently approved rates, the department is reviewing the scope of work and is continuing discussions with Raftelis to determine if a cost of service study would be an appropriate fit under the additional services component of the contract. For FY 2010 there is nothing specifically budgeted for a cost of service study as it was anticipated to be completed at a later date, mostly likely during FY 2011.

**Water**

**COUNCIL DISTRICT 7**

**QUESTION:** Provide a detail breakout of object accounts 4222 (Miscellaneous Contractual Services) and 4279 (Other Non-Personnel).

**RESPONSE:**

**Object account – 4222**

The FY 2009 Budget for object account 4222 is distributed amongst the four divisions in the Water Department. In FY 2009 the bulk of the budget is utilized by the Water Resources and Planning Division (in FY 2010 this is called the Long-range Planning and Water Resources Division) at \$3 Million. The Customer Support Division is budgeted at \$1.1 Million, Water Operations Division is budgeted at \$800,000 and Business & Support Services (in FY 2010 this has been renamed to the Financial and Information Technology Division) is budgeted at \$75,000.

**RESPONSE CONT'D:**

In FY 2009:

- Water Resources and Planning has encumbered \$1.8 Million in contracts year to date. These contracts are for the first phase of the Indirect Potable Reuse project, Urban Water Master Plan, Integrated Regional Water Management Planning and Environmental Service works related to Water. An additional \$1.2 Million in contracts is expected to be encumbered by the end of the fiscal year for projects related to ground water, water quality and research agreements. However until contracts are actually executed they are being reflected as savings.
- Customer Support has \$1.1 Million budgeted for the Automatic Meter Reading Project, which is currently delayed until Financing approvals have been received from Council.
- Water Operations and Business & Support Services set up as-needed contracts to repair equipment at the plants, reservoirs, pump stations and office. These contracts are also used for the installation of equipment at the plants, reservoirs and pump stations. Savings that might occur by the end of the fiscal year are based on the amount of maintenance required for equipment during the year.

For FY 2010, the majority of the budget is utilized by the Water Resources and Planning Division (in FY 2010 this is called the Long-range Planning and Water Resources Division) at \$12.8 Million, This funding is entirely for the Indirect Potable Reuse Project. The Customer Support Division has \$2 Million; this funding is for the Automatic Meter Reading Project. The Water Operations Division has \$900,000 a slight decrease based on needs assessment and Business & Support Services (in FY 2010 this has been renamed to the Financial and Information Technology Division) is budgeted at \$120,000. This increase is due to reallocation of funding in order to better reflect spending patterns.

**Object Account – 4279**

For FY 2009, the budgeted funds total \$177.9 Million for the Capital Improvement Project Program. These amounts are separated into \$172 Million for Municipal Water Projects and \$6 Million for Reclaimed Water Projects. The funds are moved to the various projects as expenditure needs are required throughout the fiscal year. The remaining amount of \$152,000 is for as-needed items in Customer Support Divisions and for Water Operations plant operations totaling \$30,000.

For FY 2010, the majority of the budget funds totaling \$149.8 Million are for the Capital Improvement Project Program. These amounts are separated into \$134.2 Million for Municipal Water Projects and \$15.5 Million for Reclaimed Water Projects.

**City Auditor**

**COUNCIL DISTRICT 3**

**QUESTION:** The Audit Committee recommended assigning some new positions for the audit of enterprise funds and outside agencies. Are these audits intended to be cost recoverable, particularly the audit for DPC?

**RESPONSE:** In FY 2009, the Centre City Development Corporation and San Diego Convention Center Corporation are reimbursing the General Fund for the costs of their audits. Both of those audits were outsourced. The audits of the San Diego Data Processing Corporation and Housing Commission are being performed by the City Auditor's staff and are not being reimbursed by those agencies. In FY 2010, the department will look for opportunities to enter into Service Level Agreements with enterprise funds, as was done with the Utility Department.

**City Attorney**

**COUNCIL DISTRICT 1**

**QUESTION:** What existing Service Level Agreements (SLAs) do you have with departments; which SLAs are renewals; which departments are attempting to opt out of SLAs; is it an option to opt out of SLAs; what would departments do for legal counsel, instead, if they opted out?

**RESPONSE:** Please see listing below of FY 2010 SLAs. All SLAs are renewals except for Arts & Culture. Two departments did not sign SLAs for FY 2010; Development Services and the Disability Services Program. However, under the full cost recovery accounting principles, supplies and services provided to an enterprise fund should be paid for by that fund to ensure that the full cost of those supplies and services are accounted for. Enterprise funds that pay for legal services through an SLA are guaranteed dedicated attorney services upon demand to meet their needs. If such services were not provided by the City Attorney's office, they would have to be contracted for with outside counsel and similarly paid by the Enterprise Funds or decide not to get legal advice.

**Please find within the following Q&A format, an explanation of exactly what Purchase Orders (PO's) and Purchasing Agreements (PA's) are, as well as a description of the relationship between the two purchasing elements:**

**Question:** What the difference is between POs and PAs?

**Answer:** The main differences between a PO and a PA are as follows:

PO: This is a Purchase Order, which is issued to a selected source (Vendor) to furnish the City with goods and/or services (non-professional, professional or construction related) with funds that are encumbered in order to issue payment to the selected source once the terms of the PO are fulfilled.

PA: This is a Pricing Agreement, which represents a contract that the City has with a selected source (Vendor). It is issued to internal customers and the Vendor for informational purposes only; it is used to summarize the terms of a contract. A PA is not used as a PO or to encumber funds. Pricing Agreements are always „active“ provided that the corresponding contract is active.

**Question:** Why is the file for PAs “all active” while the file for PO's doesn't specify an active status.

**Answer:** The „all active“ file is for PAs because an active Pricing Agreement should represent an active contract the City has with a Vendor. The „all“ file is for POs because once a Purchase Order is issued, the status of the Purchase Order may change based upon the City's actions against the PO (e.g. issuing receivers, issuing modifications, or issuing close-outs).
