

PETCO Park



Description

The PETCO Park management has the role of monitoring and maintaining the relationship between the City and the parties that use PETCO Park facilities, specifically the San Diego Padres Major League Baseball team. Management is also responsible for ensuring that both the City and the San Diego Padres comply with the contractual agreements set forth in the Joint Use and Management Agreement (JUMA).

Special event activity, particularly during the City's 70/30 portion of the 2009 fiscal year, resulted in a marked increase in revenue. The original budgeted amount of \$830,000 for special event revenue will have a positive variance of approximately \$500,000, creating a total revenue amount of \$1,330,000. This increase is primarily from the booking of the Madonna concert in November 2008. Although this was a one-time event, the positive relationship with the concert promoter will hopefully see more concerts being booked during the baseball off-season. The third annual USA Sevens International Rugby Tournament was also held during Fiscal Year 2009, resulting in net revenue to the City of approximately \$500,000. New events are continually being pursued by the marketing department for PETCO Park.
