#### APPROVAL OF MINUTES

Minutes from October 21, 2010. The motion was to approve the Minutes. *Motion by Commissioner Lansdowne to Adopt.* Seconded by Commissioner Lozada. *Passed unanimously.*

#### COMMUNITY INFORMATION SCAN (CIS)

- a) Gang Statistics for the month of December 2010: Chief Lansdowne and Lt. Jorge Duran
  - 1 gang related homicide, which occurred on October 2007. Individual was kept on life support until family decided to remove him from life support on December 15, 2010.
  - Two individuals were arrested and one received 20 years and the other 10 years

- Total for the year is 4 compared to 9 homicides last year
  - There were 15 aggravated assaults; total for the year is 193 compared to 245 the prior year
  - Out of those aggravated assaults , 4 were shootings, 3 were stabbings, and 6 were other (including the use of blunt objects)
  - On the suppression side, there were 76 gang arrests, which of those 72 being adults and 4 juveniles, and 7 on probation violations
  - There were 10 firearms recovered from gang members on the street
- b) Reentry Update: Commissioner District Attorney Bonnie Dumanis
- Charlene Audilino, Chair of the Reentry Roundtable
  - Began in 2002
  - Partners include: Parole, Probation, CBOs, and Faith-Based Organizations
  - Wants their sub-committee to meet with an HR department to present the myths and facts about individuals that have been incarcerated.
- c) Probation Information: Chief Jenkins
- Stacy Adams, Director of Special Operations, in the Probation Department presented information on two innovative programs that are augmenting suppression activities.
  - The first is the YOU Program, which takes a holistic approach by surrounding the probationers with positive forces, so that they can make good decisions for the rest of their lives.
  - The second program is Community Transitional Unit, which deals with serious parole youth offenses.
  - Depending on the offense the youth was involved in, he/she will be placed in either of the two programs.
  - Goal of these two programs is community integration
  - Offering Parent Retreats
- d) Parole Statistics: Commissioner Benny Benavidez
- Caseload of GPS gang members has remained consistent
  - Turnover is low
