- a) Gang Statistics for the month of Aril 2011: Chief Lansdowne and Lt. Jorge Duran
  - 4 gang related homicide compared to 4 for all of last year
  - Total for the year is 6 compared to 2 homicides last year
  - There were 15 aggravated assaults; total for the year is 58 compared to 65 the prior year
  - Out of those aggravated assaults , 16 were shootings, 2 were stabbings, and 7 were other (including the use of blunt objects)
