2. Overview of demographic data and resources in San Diego

Senior Manager Darrin Schwabe provided a presentation on sources of information of demographic data on San Diego. He showed some of the websites that were good sources of information and showed how to navigate within them.

1. Updates from 2013 Issue Committees

Executive Director Scarborough invited all the Commissioners to review the different Committees and decides which they wished to serve on. Each Committee can have up to seven members.

- a. Access – Commissioner Alcock is the chair of the Access Committee. She said the Committee is reviewing many access issues, such as CalFresh, hunger, housing, poverty and access to technology and narrowing down their focus to a few major issues to be taken on this year. Their goal is to act like a lighthouse and shine a light on an issue and then move on.
- b. Civility – Commissioner Harrison is the chair of the Civility Committee. The Committee will focus on different issues of safety, trauma and rights. The Committee will be scheduling a meeting very soon to discuss the specific issues they will focus on this year.
- c. Education – Commissioner Lee is the chair of the Education Committee. In her absence Commissioner Joyce Abrams provided the report. The Committee would like to focus on two issues; following up on student achievement with Becky Philpot from the San Diego Unified School District; and following up with UCSD and campus diversity issues. They will also work with the school district to secure a student commissioner. They will continue the Commission’s work on the Safe Schools Parent Empowerment conference scheduled for May 11.
- d. Immigration – Commissioner Slomanson is the chair of the Immigration Committee. Commissioner Bauer provided this month’s report. The Committee will schedule their first meeting to discuss their priorities for the year. Issues include border issues, human trafficking, and immigration reform. The Commission plans to continue their partnership with the SDIRC and at least one member of the Committee will attend their meetings.

Executive Director Scarborough reminded all Commissioners of their responsibilities under the Brown Act and to keep them in mind when meeting as a Committee.

There was a brief discussion on issues that cross over to different Committees and how they will be organized. The Committees were encouraged to meet over the next 60 days to prioritize their goals. The Commissioners are encouraged to meet with the Mayor or the Councilmember that appointed them to discuss their issues and see how we can work with them to reach shared goals.

The San Diego Opera will be presenting a Mariachi Opera on Saturday, March 16. There will be both a matinee and evening performance.

The San Diego Repertory Theatre will be presenting the play "The Mountaintop," a dramatization of the last night of Martin Luther King Jr.'s life. There will be a dress rehearsal that students and interested parties may attend for free on March 1

There was a discussion of where the Commission meetings will be held. We will be downtown for the next few meetings but Commissioners expressed interest of alternating meeting sites to a location in each district every third month.

Executive Director's Report:

1. Overview of SDPD Annual Crime Statistics with focus on Hate Crimes.
Executive Director Scarborough distributed the Report to the City Council on the 2012 Index Crimes. She also distributed the monthly reports the Police Department provides on Hate crimes. There was a discussion of the statistics and how it compares to nationwide statistics.
2. Process for HRC tables at community breakfasts/lunches/dinners
Most of the community breakfasts/lunches/dinners the Commissioners attend involve a cost. Executive Director Scarborough encouraged the Commissioners to partner with her on these events so they can be organized early and tickets can be secured without any individuals having to spend out of pocket for unused seats.
