Section II.B: Total Bond Reserve Fund: \$3,051,500 in Surety Bond provided by AMBAC.

Section III.B.3: CDIAC staff previously advised that outstanding principal should be reported instead of the original amount of purchase; accordingly, a total of \$4,083,392 of outstanding principal for the four remaining Limited Obligation Refunding Bonds is reported.
