NOTICE IS HEREBY GIVEN that as of March 25, 2005 the City of San Diego has not provided an Annual Report for the fiscal year ended June 30, 2004 with respect to the certificates and bonds referenced above.

The Annual Report, when filed, will not include the audited financial statements of the City for the fiscal year ended June 30, 2003, or for the fiscal year ended June 30, 2004, because such audits are not yet complete. In addition, in light of certain errors with respect to the audited financial statements of the City for the fiscal year ended June 30, 2002, which were reported to the Nationally Recognized Municipal Securities Information Repositories on January 27, 2004 and March 12, 2004, the City has determined that it would not be prudent to file unaudited financials at this time.

The City anticipates that the annual financial information required by the continuing disclosure agreements, other than the audited or unaudited financial statements, will be filed by April 29, 2005. The audited financial statements for the years ended June 30, 2003 and June 30, 2004 will be filed as soon as they become available.
