The tobacco settlement payments constituting Pledged Revenues (as defined in the Indenture) were used to redeem the Series 2006 Bonds on June 1, 2007 in the aggregate principal amount of \$2,700,000 in accordance with the Turbo Redemption payment provisions provided for in the Indenture.

This notice is filed in connection with the Continuing Disclosure Undertaking dated as of June 1, 2006 entered into by and between the Corporation and the Indenture Trustee in connection with the issuance of the Series 2006 Bonds.
