## VOLUNTARY EMMA FILING

Bob Filner resigned the Office of the Mayor, effective August 30, 2013, as part of a settlement between the City of San Diego (the "City") and Mr. Filner related to a sexual harassment lawsuit filed against both the City and Mr. Filner. The settlement did not involve the plaintiff in the lawsuit and the lawsuit is ongoing. The City Council approved the settlement on August 23, 2013. Other claims alleging sexual harassment by Mr. Filner have been made against the City. Such claims have not yet resulted in additional lawsuits. It is uncertain at this time what is the City's financial exposure in the filed lawsuit, for any claims that may become lawsuits, or for any claims that the City may determine to settle before they become lawsuits.

Pursuant to the San Diego City Charter, when there is a vacancy in the Office of the Mayor the presiding officer of the City Council, currently Council President Todd Gloria, has limited authority to exercise, when required by law, certain executive powers of the Office of the Mayor. The Council President remains a member of the City Council and has no veto authority over City Council actions.

On August 23, 2013, the City Council also confirmed Walt Ekard as the interim Chief Operating Officer of the City. Mr. Ekard has served in this capacity since July 15, 2013. The Chief Operating Officer exercises administrative control over most City departments and will report to the Council President while the Office of the Mayor is vacant.

On August 28, 2013, the City Council called a special election for November 19, 2013, to fill the vacancy in the Office of the Mayor. If no candidate receives a majority of the votes cast in the special election, a special run-off election will be held between the two candidates receiving the highest number of votes in the initial special election. The special run-off election, if necessary, is expected to occur in early 2014. The winner would serve as Mayor for the remainder of the unexpired term, which ends on December 5, 2016. Based on estimates provided by the San Diego County Registrar of Voters, a single City-wide special election for the Office of the Mayor is anticipated to cost the City's General Fund approximately \$5.9-6.2 million. A special run-off election would cost approximately the same amount. The actual total cost of each election has not yet been determined.

This voluntary filing is made on behalf of the City of San Diego and speaks only of its filing date. The City of San Diego may or may not from time to time voluntarily submit additional information.
