Please be advised that the City of San Diego Solid Waste Local Enforcement Agency (LEA) will be holding an informational public meeting in compliance with Public Resource Code §44004 regarding a revised Solid Waste Facility Permit for the West Miramar Sanitary Landfill 37-AA-0020. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the City of San Diego, including all transfer/processing facilities.

Description of Project and LEA's Determination

The West Miramar Sanitary Landfill is requesting a Solid Waste Facility Permit revision to allow for more efficient waste handling, staffing and equipment changes required by the managed competition process, standardizing the hours of operation to everyday from 7-4:30 (except for being closed on four major holidays), and revising closure date. The facility operates on a 801.445 acre site and accepts up to 8,000 tons per day of solid waste, although the current average is 2,240 tons per day. The LEA has accepted the permit revision application package as complete on 8/20/2014 and will be drafting a proposed Solid Waste Facility Permit for concurrence or denial by CalRecycle.
