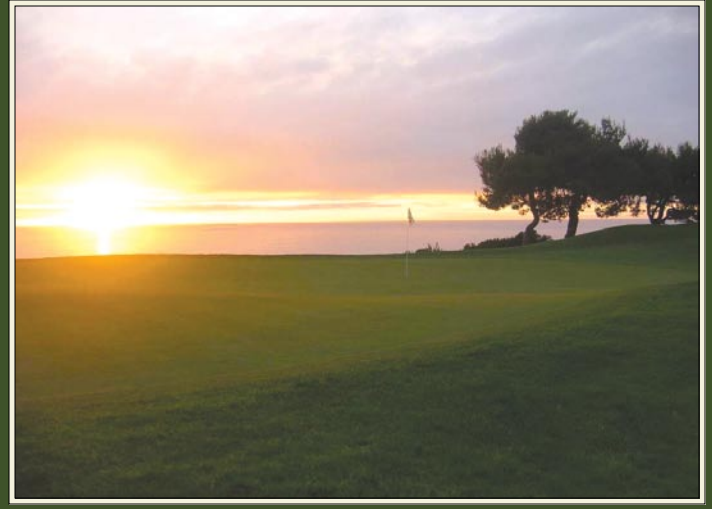

- USGA RULES APPLY EXCEPT AS MODIFIED BY LOCAL RULES**
- OUT OF BOUNDS: All fences bordering the course.
 - LATERAL WATER HAZARDS: All canyon areas adjacent to the golf course are designated by red stakes.
 - DROPS WITHOUT PENALTY: Staked trees, paved or unpaved roads/paths, flower beds, rock drains, fresh castings from burrowing animal holes.
 - WATER HAZARD: Drainage ditch #11 and pond #18.
 - EMBEDDED BALL RULE: Played through the green.
 - AVOID SLOW PLAY: Cooperate with Course Marshals. Continuous putting is encouraged.
 - ETIQUETTE PLEASE: Repair ball marks, replace divots and rake bunkers. No practicing allowed on course. Players use course at own risk and are subject to all rules and regulations of the management.
 - Keep carts a minimum of 30 feet from greens and tees.
