Ms McKenzie reported that the summer maintenance staffing for Mission Bay Park began this past Memorial Day weekend. During the summer months Fridays, Saturdays, Sundays and holidays will have an 11:00 AM - 7:30 PM maintenance shift. An additional eighteen (18) Ground Maintenance Workers I were hired for this purpose. The Ground Maintenance Workers I will work through mid September 2011.

San Diego Life Services Sergeant Troy Keach was not at the June 7, 2011 meeting.

Lieutenant James Filley, San Diego Police Department, Northern Division

Lieutenant Filley spoke on the contingency plan for the July 4, 2011 holiday. Inbound and outbound traffic seems to be the problem and they are trying to make the issue go as smoothly as possible this year. Lt. Filley also stated starting the Friday before the July 4th holiday officers will be on overtime, looking for people with couches, chairs, etc. He also stated that traffic was the biggest challenge, and that once the parking lots are full, they will be closed. Lt. Filley stated that the Gang Unit will be active in the park on July 4th.

Lt. Filley commented Floatilla doesn't seem to be a problem for this year. He also reported on Memorial Day and said Mission Bay was busy. There were citations written for DUIs along with contact with gang members. Lieutenant Filley said that last year's flash point was Kate Sessions Park, and now there is no problem due to the alcohol ban at the park.
