Dear Mike:

Tabares Entertainment is requesting to conduct Circus Vargas in Balboa Park January 31 through February 4, 2008. We request to move in on Saturday, January 26 and we will begin move-out immediately after the show on February 4 and be out of the park before 6:00 am on February 5. The specific area we are requesting is the lower portion of the large parking lot on the corner of Park Blvd and Presidents Way.

Circus Vargas is a one-ring theatrical circus. It is a family show with acrobats, clowns, comedy and other circus performances. There are no exotic animals, no mechanical rides, no games of chance and no alcohol is served. The entire operation consists of the performance tent, a concession trailer, a ticket trailer and associated support vehicles.

Shows are about 90 minutes in length. Shows will start at the following times: January 31: 7:30 pm; February 1: 4:30 pm and 7:30 pm; February 2: 2:00 pm, 4:00 pm and 7:30 pm; February 3: 1:30, 4:00, 7:00 pm; and February 4: 7:00 pm. We anticipate about 300 to 500 spectators per show.

I have attached a plot plan that indicates that we will only take up about 250 parking spaces in the lower portion of that lot, leaving free the entire upper section of the lot as well as the bus parking and additional car parking in the lower section.

There should be minimal impact on the park and surrounding areas since we will not be closing any streets, there will be plenty of parking remaining in that lot and we do not have any amplified sound, other what is played inside the tent during the shows, which should end by about 9:00 pm every night.

It is our understanding that the rental fee will be \$5.00 per parking spot we use and ten percent of that fee goes to the Recreation Council.


