301. **Old Globe 2009 Gala** - Lou Spisto, Todd Schultz and Eileen Prisby  
Proposal to hold the annual fundraiser in the Alcazar Garden on Saturday, July 25, 2009 from 5:00 p.m. to 7:00 p.m.. The event includes a silent auction and guest reception before guests attend the dinner dance in the Copley Plaza at the Old Globe Theatre. The first two rows of the Alcazar Garden Parking Lot will be

used as event load in and a valet station drop off/pick up zone for guests attending the event. The garden area will be closed to all other events during the set up beginning at 6:00 A.M. and the portion of the lot will be closed to public parking all day. Estimated attendance is 550 patrons. This event has previously been held in September.

**STAFF RECOMMENDATION:** To approve the event as presented based on the presumption that the amount of traffic with the park will actually decrease from an estimated 1500 patrons to 550 patrons because The Old Globe will not hold performances in either the Festival Theatre or Copley Auditorium that evening. A mitigation of impact must be met by all other park institutions
