Request approval to conduct a 5K charity walk and community festival on Saturday, November 21, 2009 at the 6th Ave Lawn Area location in Balboa Park. The proposed walk route will travel on park paths and public sidewalks between Juniper St. and Upas Ave. from 8:00 a.m. to 9:30 a.m. The proposed festival site is the 6th Ave Lawn, South of El Prado. The festival will include live entertainment, food & beverage and a resource fair, it will conclude at noon. The estimated attendance for this event is 3500 people. There will be no road, parking lot or bridge closures during this event.

STAFF RECOMMENDATION: To approve this special event on the date and site proposed. Stipulations include; a comprehensive parking and shuttle plan which encourages event volunteers to park in the Marston Loop lot and participants to park in the Inspiration parking lot. Traffic controllers will be used at key road intersections. The use of bounce houses are not allowed in Balboa Park. Amplification may not start prior to 7:30 a.m. with entertainment starting at 9:30 a.m. The P.A. system must be positioned to face toward the East, away from residents living along 6th Ave.
