Thyme Curtis, Council District 2

• Ms. Curtis reminded the Committee about Councilmember Faulconer's State of the District meeting on April 27, 2009 at 6:30p.m. at the Old Town Theater. • Ms. McKenzie spoke on the proposed fees and charges as it relates to Mission Bay Park. As an example, a venue is now considered one park area, if the proposed fee schedule is approved and if an event used several parks, they will pay a ground use fee for each venue (park) used.

Sergeant Mark Heacox, San Diego Police Department

• Sgt. Heacox reported that Captain Shelley Zimmerman will attend the Mission Bay Park Committee meeting in May. Sgt Heacox said the spring break went well. Sgt. Heacox said the crowds were larger, but better behaved than in the past; it is believed the high police presence and visibility has lowered crime.

Sergeant John Everhart, San Diego Lifeguard Fire and Rescue

• Sgt. Everhart said Mission Bay Park hasn't seen too many crowds as yet. Sgt. Everhart feels the crowds may increase during the upcoming boating season. Sgt. Everhart reported the surveillance camera funding has been secured and thirteen to sixteen cameras should be up and running by 2010. Sgt. Everhart also mentioned that due to budget cuts, Lifeguards lost two full time staff members.

501. Status of Leases in Mission Bay Park: Gary Jones, Real Estate Assets

Mr. Jones provided status of several leaseholds in Mission Bay Park:

<u>Everingham Bait Barge</u>: Needs Council approval, estimated completion April 2009 <u>Mission Bay Sports Center</u>: Waiting for Park & Recreation recommendation, estimated completion June 2009

Hilton Hotel: Waiting response on proposed lease amendment, estimated completion June 2009

Paradise Point- Waiting response on proposed lease amendment, estimated completion June 2009

Bahia Sternwheelers: Rent appraisal and define terms, estimated completion September 2009

Dana Landing: Waiting Park & Recreation approval, estimated completion is unknown

Boat and Ski Club: A meeting was held and terms proposed, estimated completion unknown

Mission Bay Yacht Club: Staff review, estimated completion unknown

- 502. Rock and Roll Marathon-Kari Logan Elite Racing.
 Rock and Roll Marathon is May 31, 2009. This event will be the same as in past years.
 They expect 16,000 finishers and 4,000 volunteers.
- 503. Bay and Beach Water Testing-Mark McPherson, San Diego County Department of Environmental Health.

Mr. McPherson reported that the program resumed April 1, 2009 and will run through October 31, 2009. Supervisor Cox and other Board of Supervisor's received \$150,000.00 for limited testing at sixteen sites, six of which are in Mission Bay Park. Testing is done for biological which is mandated by the state.

504. Update on Mission Bay Park Projects: Fiesta Island and Briarfield - Stacy McKenzie reported on information provided by Paul Jacobs, Associate Civil Engineer, Park and Recreation Department.

Briarfield: The residents have retained an attorney who is attempting to negotiate with the City for a partnership between the homeowners and the City for permitting and long term maintenance dredging the cove. Homeowners desire a long term permit to be able to keep the cove dredged in perpetuity rather than get a single dredging permit, which they feel they can get through a joint venture with the City. The status of negotiations is unknown at this time.

Fiesta Island: Consultant, KTU&A, is working on an analysis of alternate sites for paddle clubs somewhere other than Fiesta Island, specifically South Shores embayment and Mariner's Point. This work is an "add-on" to the consultant's contract amendment. Park and Recreation is trying to set up a meeting with the Coastal commission to get a better

understanding on their view of locating the parking improvements for the public beach at the southern end of the island to a location several hundred feet farther to the north to facilitate unrestricted off-leash access across the southern end of the island. There have been conflicting interpretations of the Coastal Commission's comments in regard to whether or not a relocation of this parking would still be considered "public access" to the beach. Pending an opinion from the Coastal Commission, a decision will be made on whether or not to re design the improvements on the southern part of the island.
