San Diego Cyclo-Vets is requesting approval to increase the time of their use of Fiesta Island from 7:00AM - 9:00AM (standard race permit time frame) to 6:00 AM - 9:30 AM for the time trail races to be held Friday, April 9, 2010. Ms. Hamilton is requesting the increase in time in order to allow three hundred (300) race registrants to complete the race course.

STAFF RECOMMENDATION: Recommendation would be to allow the earlier start at 6:00 AM but keep the traditional 9:00 AM as the end time. Bicycle racing permits on Fiesta Island require the entire island to be closed during the event. There are a number of regular user groups who are required to stay off the island when it is closed. Increased closure creates problems for all the other users of the Island.
